## With Charles Gibbs at the helm, the association flourished Financial planning, sound investments second nature to treasurer

For several years, the alumni association members had gathered over cups of coffee in the kitchens of members' homes or after hours in the offices where they worked to pour over finances and make decisions about student scholarships.

That was the way they'd always operated, since the first scholarship fund was established in 1903 - in four years, they had enough money to buy a \$1,000 bond. In 1908, the \$60 interest was given to a Salem High graduate, Walter French.

The rule was never to touch the principal, and as the years passed, the interest grew and more and more scholarships were handed out to graduating seniors.

Both Charles Gibbs and Dan Smith started their careers in Salem, and were closely involved with the association activities. Dan, a 1946 graduate, opened a jewelry store downtown. Charles, who graduated in 1943, started out as a branch manager at the First National Bank across the street from Dan's store, and advanced to assistant cashier and cashier. He was promoted to senior vice president in 1972 and to executive vice president and then president after First National was taken over by Society Bank in 1984.

Investments and finances were second nature to Charles, and in 1977 he accepted the position of treasurer of the scholarship committee and the association, and chairman of the investment committee. He couldn't have envisioned it then, but he would retain the posts for 25 years, until his retirement this year.

Record keeping became more demanding, and packing and unpacking

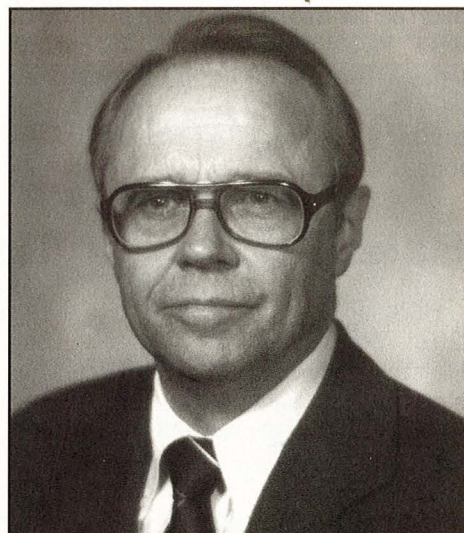
the association books from one meeting place to another was a chore. A permanent home was the answer, a base for the association and a site where alumni could get together when they wanted to organize reunions and meetings. For alums who lived out of town and out of state, an association office would be a perfect place for them to stop over and visit when they were in the city.

Dan Smith came up with the answer. Above his jewelry store were 1,200 square feet of vacant space which both he and Charles thought would be perfect for the association's first home. Dan offered the quarters to the association on a 15-year rent-free basis, and the two men cleaned out the years of cobwebs and dust and moved the association in.

The main office was at the front of the quarters, and a meeting and exhibit room and kitchenette were at the rear. The office opened in the early summer of 1984, and by summer's end was decorated with draperies, desks, and chairs. A limited mail solicitation to 18 Salem High alumni classes had brought an immediate response.

Charles' service to the association and his business acumen were recognized in 1986 when he was selected Outstanding Alumnus of the Year. The association had been honoring a distinguished graduate since 1958, when Fred E. Cope of the Class of 1925 was given the award.

Russell and Sara Pearce Gibbs raised two daughters and two sons, Nanee Bennett and Elizabeth Thatcher and Charles and his brother, James. After his high school graduation, he served in the Navy. World War II was still going on, and Charles served in the Pacific Theater before being discharged. Returning home, he enrolled in classes



at Adelbert College, Western Reserve University in Cleveland and graduated in 1948 with a Bachelor of Science degree in biology. Later on, he enrolled at the Graduate School of Banking at the University of Wisconsin.

He married Margaret Works in 1950 in the First Presbyterian Church, and the couple had a son, Charles Pearce of Freedom, New Hampshire, and three daughters, Ellen Caruso of Canton, Emily Gibbs of Salem and Margaret Hoople of Falmouth, Maine. They have two grandchildren, Jeremy Gibbs and Ashley Gwin.

The church has been a vital part of the Gibbs' life in Salem, and Charles served as a deacon and trustee and member of the investment committee.

He branched out into the community as a city councilman for 12 years and as chairman of the city's finance committee. For 17 years he was a member and chairman of the City Utilities Commission, retiring as chairman in 1991. Treasurer of the Salem Rotary

Club, he is a trustee for Century House for aged men and women, a member of the Salem Golf Club, the selection committee for the Salem Hall of Fame, and a member of the Grandview Cemetery Board.

President of RCG, a real estate development corporation, Charles was president of the American Laundry and Dry Cleaning Inc. and a board member of Peoples Lumber Co. From 1987 to 1992 he was a senior vice president of the Firestone Bank of Lisbon.

When Charles retired from the association earlier this year, he left a portfolio of wise investments and a marvelous legacy. The \$1,000 bond purchased by alumni in 1904, the principal of the first transaction, has grown to over \$5 million today.

## Salem historian Dale Shaffer '47 publishes history of city

Historian and author Dale Shaffer's latest book, "Salem: A Quaker City History" documents the town's unique story over the past 200 years, beginning with Elisha Schooley's cabin in 1801 and spanning the town's evolution over succeeding decades.

Dale traces, in word and image, the story of Salem from its founding to the present, highlighting major events and personalities that have shaped the community's character and heritage. The book is a marvelous resource for understanding the city's history and its legacy of morality and self-reliance.

Within the pages of the book, the reader will meet the town's earliest citizens and its founding fathers, Zadok

Street and John Straughan and experience firsthand the changing landscape through the struggles and triumphs of the settlers.

Dale says that Salem is a model community of the best that small-town America offers, and represents good values, a peaceful setting a host of men and women grounded in prudence, integrity and resolve. The combination of Quaker spirituality and pioneer resourcefulness helped its first settlers in the beginning of the 19th century to carve out a lasting home in America's beckoning wilderness. Against a backdrop of two centuries, Salem evolved from a simple Quaker outpost into a thriving community.

A timeline at the end of the book summarizes important dates of major developments from 1800 to 2000. The bibliography lists important reference sources used in researching the book.

## National Football Foundation, Hall of Fame honors Lou Slaby

Louis R. Slaby '59 was honored with a Distinguished American Award at the 27th annual scholar-athlete awards dinner of the Passaic County Chapter of the National Football Foundation and College Hall of Fame in Haledon, N. J. in May.

At Salem High, Lou starred in track, football and basketball. He was selected as an All-Ohio Linebacker and voted first team member of the high school's All Time Football Team. When he graduated, he received over 50 scholarship offers. In basketball, Louis was a co-

captain and voted a first team member of the high school All Time Basketball Team. In track and field, he set a school record for the shot put.

At the University of Pittsburgh where he graduated with a bachelor of science in mechanical engineering, he was an outstanding fullback and linebacker, and played in the All-American Bowl and the Crusader Bowl.

Slaby was drafted in the fifth round by the New York Giants and played linebacker for three seasons until he was traded to the Detroit Lions where he

played one season. His career was cut short by injuries, but he was named New York Giants Rookie of the Year, selected to the All Rookie Team and B'nai B'rith awarded the Award for High Principles and Achievement.

Lou is president of the Louis R. Slaby Engineering Associates Inc., a firm he founded in 1986. He has received numerous awards, but one of the most prestigious is when he was listed as one of the 100 people who shaped Columbiana County in the 20th century.



# Student Activity Multiplex will benefit students

A Student Activity Multiplex (SAM) is being proposed by a group of local citizens of Salem who recognize the need to upgrade and improve the school athletic facilities in Salem. The multiplex would be built on the west side of the high school near the current gymnasium and band room.

The Salem Athletic Booster Club's goal is to raise \$1.5 million through private donations, and are asking alumni to help them.

A donation of \$200,000 has been donated by Bob '54 and Karen Sebo to the Boosters for the proposed facility. The Boosters hope to raise the funds through private contributions like the generous donation from the Sebos.

During the past 30 years, the number of athletic programs in the system has doubled. The growth is attributed to meeting gender equity in all sports and increased student participation in the middle and high school levels.

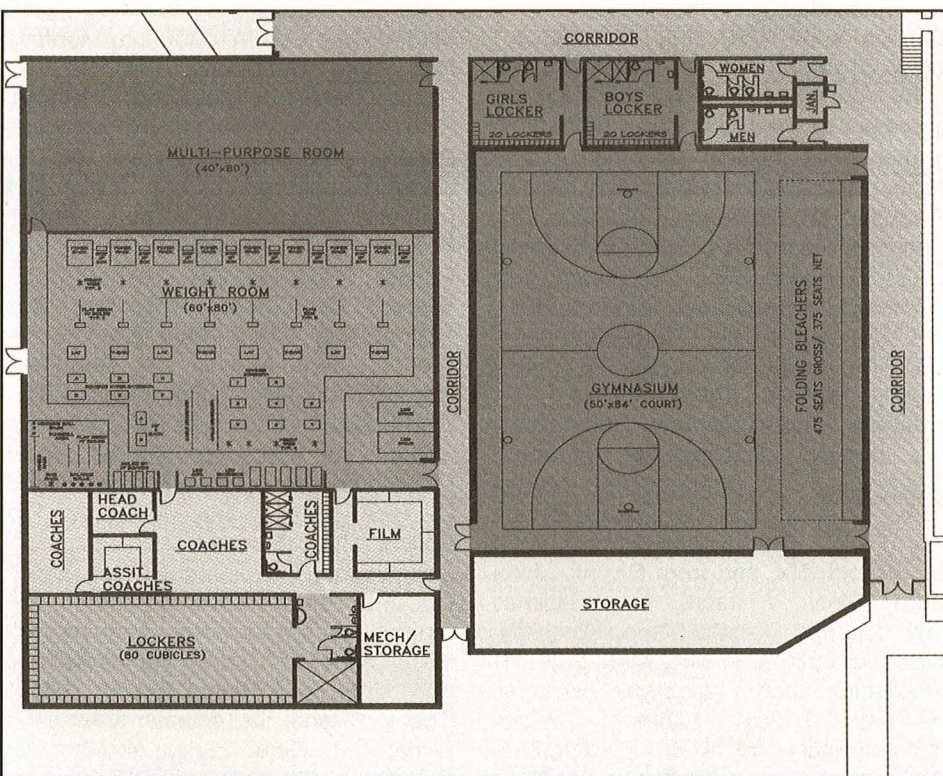
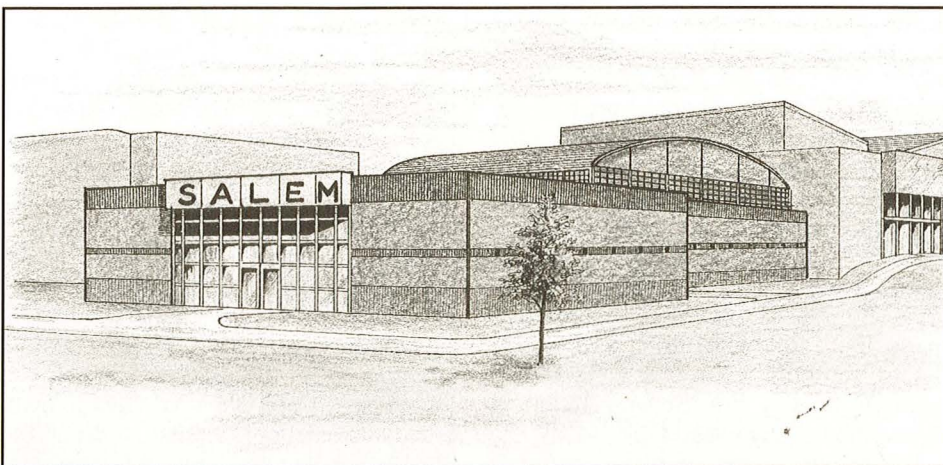
The existing physical education and athletic facilities can't accommodate the daily and seasonal needs of student athletes. During the winter, it's not unusual for five or six groups to be using the high school facilities at one time. This isn't conducive to a good learning or workout experience.

The project originally began with a discussion of the need to upgrade the current weight facilities at Salem High School. The weight area is located on the second level of the gymnasium and wasn't constructed to bear the weight of the heavy equipment. Further discussion identified needs for a multi-purpose room and gymnasium, and plans for the SAM Center were under way. The multiplex will be built in phases, with the weight room being the first priority.

Many area and league schools have upgraded or are in the process of upgrading their facilities. To maintain equity and to attract families to the Salem area, the Boosters feel the facilities must be improved and upgraded.

Funding categories for donations, both corporate and individual, which are tax deductible are: \$50,000, a plaque and picture; \$25,000, plaque and picture; \$10,000, recognition plaque; \$5,000, recognition plaque; and \$1,000, recognition tile.

## Long Distance calling program is beneficial to association

feel that this six second billing increment is what produces the tremendous savings on our phone bills. However, there is a \$2.95 monthly fee, which is waived in any month your monthly usage is \$25 or more. Manager shall have charge of the Scholarship Fund, which fund shall be kept entirely separate from the regular funds of the Association.

The Scholarship Committee is authorized and empowered to receive money or property, real or personal, by gift, bequest or devise. The title to all property shall be in the name of The Scholarship Committee. The Scholarship Committee is authorized and empowered to invest any monies in its possession, to sell and convey any of its property, whether real or personal, and to invest the proceeds therefrom in other property, real or personal, and to make loans secured by real estate mortgage.

The principal of said fund shall be invested and re-invested at the discretion of the Scholarship Committee, and the income is to be used for scholarships for worthy graduates of the Salem High School, annually or otherwise, and to such number of recipients and in such amounts as the Scholarship Committee shall determine. Income may also be used to apply to Salem High School Alumni Association operating expenses, capital improvements, equipment, facilities, consulting fees, etc., in such amounts as may, from time to time, be determined to be necessary or reasonable, by The Scholarship Committee.

The Scholarship Committee shall employ such guidelines/policies in connection with its selection of scholarship recipients as it may, from time to time, enact/adopt with the general objective to be the awarding of a scholarship or scholarships to a deserving student or students who may be expected to complete his or her college education in such manner as to bring credit to the Salem High School. Factors to be considered by The Scholarship Committee in the selection of scholarship recipients shall include but not be limited to: scholastic achievement, extracurricular activities, and personality. Financial need may be considered in conjunction with other factors in the selection of scholarship recipients, but shall not, in and of itself, be determinative.

Nothing herein shall preclude The Scholarship Committee, in its discretion, from awarding a scholarship or scholarships for specific purpose or based upon specific factors (e.g., athletic achievement, vocational training/education, etc.)

Scholarships awarded by The Scholarship Committee shall be subject to such terms, conditions, restrictions, etc., as The Scholarship Committee may, from time to time, in its sole discretion, adopt.

In the event a recipient is not able to utilize his or her scholarship in accordance with said terms, conditions, restrictions, etc., The Scholarship Committee may, upon application by such recipient, modify the requirements on a case-by-case basis, as may be deemed appropriate by The Scholarship Committee.

A financial report and a report of the scholarship award(s) shall be made at the annual membership meeting each year.

## **ARTICLE X**

There shall be a nominating committee which shall be comprised of two (2) members from the Executive Committee, two (2) members of the Scholarship Committee, and the President of the Alumni Association. The representatives from the Executive Committee and the Scholarship Committee shall be selected annually by the members of those committees, from their membership.

The nominating committee shall, annually, receive and consider nominations for those Executive Committee and Scholarship Committee membership positions which are scheduled for election at the next annual membership meeting. The nominating committee shall select a slate of candidates for those positions, which slate of candidates shall be presented for a vote by the membership at the annual membership meeting. Any regular or honorary member of the Association shall be entitled to submit nominations to the nominating committee for consideration. Procedures, deadlines, etc., in connection with the receiving and processing of nominations shall be determined by the nominating committee. Annual deadlines for receipt of nominations shall be published in the alumni newsletter (subject to availability of that publication as set forth in Article XI herein)

## **ARTICLE XI**

As the financial condition of the Association permits, an alumni office shall be maintained, which office shall house Salem High School memorabilia and records of the Association.

As the financial conditions of the Association permits, an alumni newsletter shall be published and distributed to members not less than annually.

## **ARTICLE XII**

The Executive Committee and the Scholarship Committee shall, jointly, manage and supervise the operations of the Alumni Association office, including specifically staffing of such office and the delegation of duties to staff members/employees.

Joint meetings of the Executive committee and the Scholarship Committee for the purpose of conducting business relating to the Alumni Association office shall be organized and held by the Chairmen of said Committees, as necessary.

Policies, procedures, decisions, etc., relating to Alumni Association office operations, which originate in the Executive Committee or the Scholarship Committee shall not be effective unless and until presented to and approved by the other Committee.

## **ARTICLE XIII**

The by-laws or any part of them may be amended or suspended by a two-thirds vote of the regular members present at any regular or special meeting of the Association, at which a quorum, as set forth above, is present.

It is our hope that the adoption of the new by-laws will allow our association to continue to grow and operate in an efficient, effective and organized manner. **PROPOSED BY-LAWS OF THE SALEM HIGH SCHOOL ALUMNI ASSOCIATION  
October 2002****ARTICLE I  
INCORPORATION**

This Association shall be called THE SALEM HIGH SCHOOL ALUMNI ASSOCIATION.

The mission of The Salem High School Alumni Association is to recognize and award scholarships to deserving Salem graduates who are expected to continue their education in a manner that will bring credit to Salem High School. The organization strives to keep alive memories of high school days and friendships through the association newsletter, yearbooks, and archived records and memorabilia of Salem High School in the Association office.

**ARTICLE II  
MEMBERSHIP**

Regular membership to this Association shall be limited to the Alumni of the Salem High School. The affairs of the Association shall be governed by a Board of Trustees elected by the regular membership and shall number no more than eighteen (18) members.

Honorary membership in the Association shall include the present and former administrators and superintendents, teachers of the Salem High School, members of the Board of Education who are not regular members, and such other persons as may be nominated at a meeting of the Trustees and receive a majority vote. Honorary members shall be admitted to all the privileges and courtesies of the Association, but shall have no vote nor hold any office.

**ARTICLE III  
TRUSTEE TERMS AND ELECTIONS**

All Board of Trustee members shall be elected at the annual membership meeting of the Association. The Trustees shall be elected for a term of three years, and no member shall serve more than three consecutive terms. Trustee terms are to be set so as to result in a staggered rotation, with an equal number of members to be elected each year.

In the event a vacancy or vacancies occur, the remaining Trustees shall fill such vacancy or vacancies for the balance of the term.

**ARTICLE IV  
ABSENCES**

Unexcused absences from two consecutive meetings of the Board of Trustees by a Trustee shall constitute a resignation and the Board of Trustees shall notify the trustee of its acceptance of the resignation by letter and shall arrange to fill his or her vacancy. An absence is considered unexcused when the Secretary of the Board has not received notification prior to a meeting.

**ARTICLE V  
OFFICERS AND DUTIES**

There shall be a President, two Vice Presidents, Secretary, and Treasurer of the Association, who shall be nominated by the Board of Trustees, from its membership. These officers shall be elected each year at the annual membership meeting, for a term of one year.

The President shall preside over all meetings of the Board of Trustees and at the annual meeting of the Association.

The 1st Vice President shall be chairman of the Scholarship Committee and shall perform the duties and exercise the power of the President during the absence or disability of the President.

The 2nd Vice President shall be chairman of the Alumni Relations Committee and shall perform the duties and exercise the power of the President dur-



ing the absence or disability of the President and 1st Vice President.

The Secretary shall attend all regular meetings of the Board of Trustees and shall preserve in the books of the Association true minutes of the proceedings of these meetings. The Secretary shall perform such other duties as may be designated by the President.

The Treasurer shall be responsible for custody of all funds and securities belonging to the Association, and have all Association monies deposited into depositories designated for that purpose by the Board of Trustees. The Treasurer shall also be responsible for keeping records of all receipts and disbursements of the Association monies. The Treasurer and a designated Trustee shall sign checks issued in the name of the Association.

## **ARTICLE VI COMMITTEES**

There shall be five (5) standing committees: Alumni Relations, Executive, Finance, Nominating, and Scholarship. Every Trustee shall serve on a standing committee; there shall be a minimum of three (3) Trustees on each committee.

The Alumni Relations Committee shall be chaired by the 2nd Vice President and shall be responsible for the selection of the alumnus of the year, organizing the annual membership meeting, fundraising / fundraising, and the Association newsletter.

The Executive Committee shall be chaired by the President and shall consist of the incumbent officers and the immediate past president. The Executive Committee shall manage the affairs of the Association, subject to its By-Laws, and shall have power and authority to do all acts and perform all functions of the Board of Trustees in the intervals between regularly and/or special meetings of the Board. The Executive Committee shall be responsible for the personnel matters regarding the day-to-day operations of the Association Office.

The Finance Committee shall be chaired by the Treasurer and shall be authorized and empowered to receive money or property, real or personal, by gift, bequest or devise. The title to all property shall be in the name of The Salem High School Alumni Association. The Finance Committee is authorized and empowered to invest any monies in its possession, to sell and convey any of its property, whether real or personal, and to invest the proceeds therefrom in other property, real or personal, and to service existing loans secured by real estate mortgage. A report on the financial condition of the Association shall be made at the annual membership meeting.

The principal of said fund shall be invested and reinvested at the discretion of the Finance Committee, and the income is to be used for scholarships for worthy graduates of the Salem High School. Income may also be used to apply to Salem High School Alumni Association operating expenses, capital improvements, equipment, facilities, investment advisory fees, Treasurer pay, and any other consulting fees, in such amounts as may, from time to time, be determined to be necessary or reasonable, by the Finance Committee.

The Nominating Committee shall be chaired by the President and shall be comprised of one (1) member of each of the standing committees. The Nominating Committee shall receive nominations for board vacancies. The Nominating Committee shall also propose a slate of officers to be approved at the annual membership meeting.

The Scholarship Committee shall be chaired by the 1st Vice President and shall follow the written policies in the selection of scholarship recipients. Scholarships awarded shall be subject to such terms, condition, restriction, etc., as the Board of Trustees may adopt.

## **ARTICLE VII MEETINGS**

The annual membership meeting of the Association shall be held in conjunction with the scholarship awards banquet, or at such other time as may be designated by notice. Such notice shall be published in the local newspaper designating the time, date and place of the meeting and shall appear at least five (5) but not more than ten (10) days prior to the meeting.

Regular meetings of the Board of Trustees shall be held at least quarterly at such time and place as the president shall direct. A re-organizational meeting of the Trustees will precede the annual meeting. The president shall call such additional meetings as necessary. Any four (4) Trustees may request a special meeting of the Board.

## **ARTICLE VIII QUORUM**

Twenty members (20) of the Association, present in person, shall constitute a quorum for a meeting of the members. A majority of the Board of Trustees, present in person, shall constitute a quorum for a meeting of Trustees.

## **ARTICLE IX AMENDMENTS**

These By-Laws may be amended at any meeting of the regular membership of the Association or Board of Trustees by a vote of the majority present. A written notice stating the text of the proposed amendment or amendments shall be sent to every Association member at least five (5) days in advance of the scheduled meeting or be published in the local newspaper.

## **ARTICLE X CORPORATION**

This Association operates under the corporation, "The Scholarship Committee, Inc. of the Salem High School Alumni Association".



## **CURRENT BY-LAWS OF THE SALEM HIGH SCHOOL ALUMNI ASSOCIATION (REVISED 1991)**

### **ARTICLE I**

This Association shall be called THE SALEM HIGH SCHOOL ALUMNI ASSOCIATION.

### **ARTICLE II**

Regular membership to this Association shall be limited to the Alumni of the Salem High School and the current principal of the Salem Senior High School.

### **ARTICLE III**

A quorum shall consist of not less than twenty regular members of the Association.

### **ARTICLE IV**

Honorary membership in this Association shall include the present and former superintendents and teachers of the Salem High School and members of the Board of Education who are not regular members, and such other persons as may be nominated at a meeting of the Association and receive a two-thirds vote of all members present.

### **ARTICLE V**

Regular members shall have complete control of the affairs of the Association. Honorary members shall be admitted to all the privileges and courtesies of the Association, but shall have no vote in its management, nor hold any office.

### **ARTICLE VI**

There shall be an annual membership meeting, to be held in conjunction with the annual alumni banquet, at or near the end of each school year.

### **ARTICLE VII**

There shall be a President of the Association, who shall be nominated by the Executive Committee, from its membership and who shall be elected each year at the annual membership meeting, for a term of one year.

### **ARTICLE VIII**

The Executive Committee shall consist of ten members, which shall include a Chairman, who shall be the President of the Association; a Vice-Chairman; a Secretary; and a Treasurer. The Vice-Chairman, Secretary and Treasurer shall be selected annually by the Executive Committee members, from their membership.

All Executive Committee members shall be elected at the annual membership meeting of the Association. The Executive Committee members shall be elected for a term of three years, and no member shall serve more than three (3) consecutive years. The Executive Committee shall cause the dates of committee member terms to be set so as to result in a staggered rotation, with an equal number of members (or as nearly so as can be accomplished) to be elected each year.

In the event a vacancy or vacancies should occur in the Executive Committee for any cause, the remaining members of the Executive Committee shall fill such vacancy or vacancies. The vote of a majority of the remaining members shall be necessary for such choice. The member or members so chosen shall hold their office for the balance of the term of the member or members they are chosen to succeed and until their successors are duly elected and have accepted their position.

The Executive Committee shall meet not less than once each year, and at such other times as shall be determined by the Chairman.

The Executive Committee shall organize the annual membership meeting and banquet.

### **ARTICLE IX**

The Scholarship Committee shall consist of ten members, all of which shall be voting members, and which shall include a Chairman, a Vice-Chairman; a Secretary; a Treasurer/Scholarship Fund Manager; The Salem High School Principal; the President of the Executive Committee; and one additional member of the Executive Committee to be selected annually by the Executive Committee. The Salem High School Principal, the President of the Executive Committee, and the additional Executive Committee member selection shall automatically be members of the Scholarship Committee, and shall not require election to membership nor be subject to term limitations. The Treasurer/Scholarship Fund Manager shall be selected by majority vote of the Scholarship Committee members (exclusive of the Treasurer/Scholarship Fund Manager, who shall not have a vote in such selection process), shall serve in such capacity at the discretion of the Scholarship Committee members (exclusive of the Treasurer/Scholarship Fund Manager, who shall not have a vote in such matters), and shall not be subject to term limitations. The Chairman, Vice-Chairman, and Secretary shall be selected annually by the Scholarship Committee members from their membership.

Scholarship Committee members (with the exception of the Salem High School Principal, the President of the Executive Committee, the additional Executive Committee member selection, and the Treasurer/Scholarship Fund manager) shall be elected at the annual membership meeting of the Association. The elected Scholarship Committee members shall be elected for a term of three years, and no such member shall serve more than three (3) consecutive terms. The Scholarship Committee shall cause the dates of elected committee member terms to be set so as to result in a staggered rotation, with an equal number of members (or as nearly so as can be accomplished) to be elected each year.

In the event a vacancy or vacancies should occur in the Scholarship Committee for any cause, the remaining members of the Scholarship Committee shall fill said vacancy or vacancies. The vote of a majority of the remaining members shall be necessary for such choice. The member or members so chosen shall hold their office for the balance of the term of the member or members they are chosen to succeed and until their successors are duly elected and have accepted their position.

In order to facilitate the handling of property and investments, the Scholarship Committee shall be incorporated as a corporation not for profit and shall be known as "The Scholarship Committee, Incorporated, of the Salem High School Alumni Association." The Treasurer/Scholarship Fund

## Class ring collection is growing

Our collection of class rings is growing! Since the article appeared in the Spring/Summer '02 newsletter, we have had some wonderful additions to the collection. They include a 1928 ring, which, together with the 1929 ring we had, are unique in their appearance. We also have another very special ring: the 1916 class ring of Ella Thea Smith Cox, who later taught biology at SHS and wrote the biology book, *Exploring Biology*, which became the standard of its time. This ring has the Quaker Lady head on it, our now-classic image that was modeled by Ella Thea Smith's mother. These early rings are beautiful and easy to think of as representative because there was just one style available for the whole class. The later rings are typically one of a kind because the students personalized them with their individual interests and symbols. At the moment we have rings from 1916, '28,

'29, '32, '38, '39, '41, '43, '44, '45, '52, '55, '58, '69, '70, '72, '73, '74, '79, and '90. We are looking forward to showing off our collection in the display case that a SHS grad has offered to build. Many thanks to the SHS grads who have mailed their rings in, or climbed our "mountain of stairs" to donate a ring.

Another "collection" has been growing in the high school office these past years, but also needs alumni help. Darlene Keller Heineman, '68, the registrar and secretary to the principal, has been collecting the Commencement booklets from the very beginning of Salem High School to the present time. We had a few here at the office, and were able to complete some very early years, but the following years are still missing: 1885, 1887, 1888, 1891, 1892, 1897, 1994, 1996, and 1997. Any help in completing this collection would be greatly appreciated.

## Jewelry designer Renee Lewis '67 has thriving Manhattan business

Antique Georgian, Victorian and Edwardian-designed jewelry is the basis for many of the modern designs created by Renee Lewis, whose work is available at Barneys and Bergdorf Goodman in New York.

When Renee left Lisbon in 1980 to live in Manhattan, she vowed to earn her living solely by making art. She sculpted, painted, designed furniture and made lavish curtains from strands of gemstones. With her earnings, she bought antique jewelry.

The dozens of tiny drawers in the dental cabinet in her studio is filled with antique pieces which she uses in her one-of-a-kind jewelry. Her diamond shakes feature hundreds of tiny dia-

monds, a mix of periods, styles and shapes, which are encased in antique crystal vessels and worn as pendants or brooches. Some of these shakes may contain 100 or more carats of diamonds. As the diamonds are shook, the motion subtly changes the piece, which makes for their unique nature.

Diamonds evenly spaced on a chain are popular today, but Renee gives the concept a twist by using only antique diamonds of different carat weights, cuts and colors on the same strand. A pair of drop earrings might feature an amethyst atop a sapphire one and reverse to a sapphire atop the amethyst on the other earring.

Typical prices for Renee's "modern

treasures" are a set of amethyst and sapphire earrings for \$3,800, the 60-carat diamond shake necklace for \$100,000; a platinum necklace with 18th century rose cut diamonds, \$10,000; silver and rock quartz earrings, \$2,200; an aquamarine and platinum necklace, \$5,900; antique black opal mosaic 18k yellow gold snake chain, \$995; an 18 k gold Columbian emerald necklace, \$6,600; 18k gold ring with yellow sapphire and diamonds, \$9,700.

Renee's jewelry has been shown in stores in New York, Chicago, Beverly Hills, Boston, and Japan. Her vintage couture collection was displayed in Barneys in New York in 1999.

## Broyles retires from health auditor post

The Howard "Doc" Pardee Band Scholarship Fund is entering into its Phase II, with the goal of \$45,000.

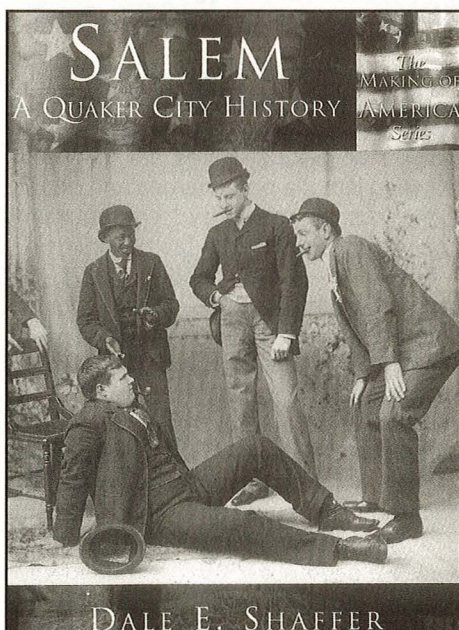

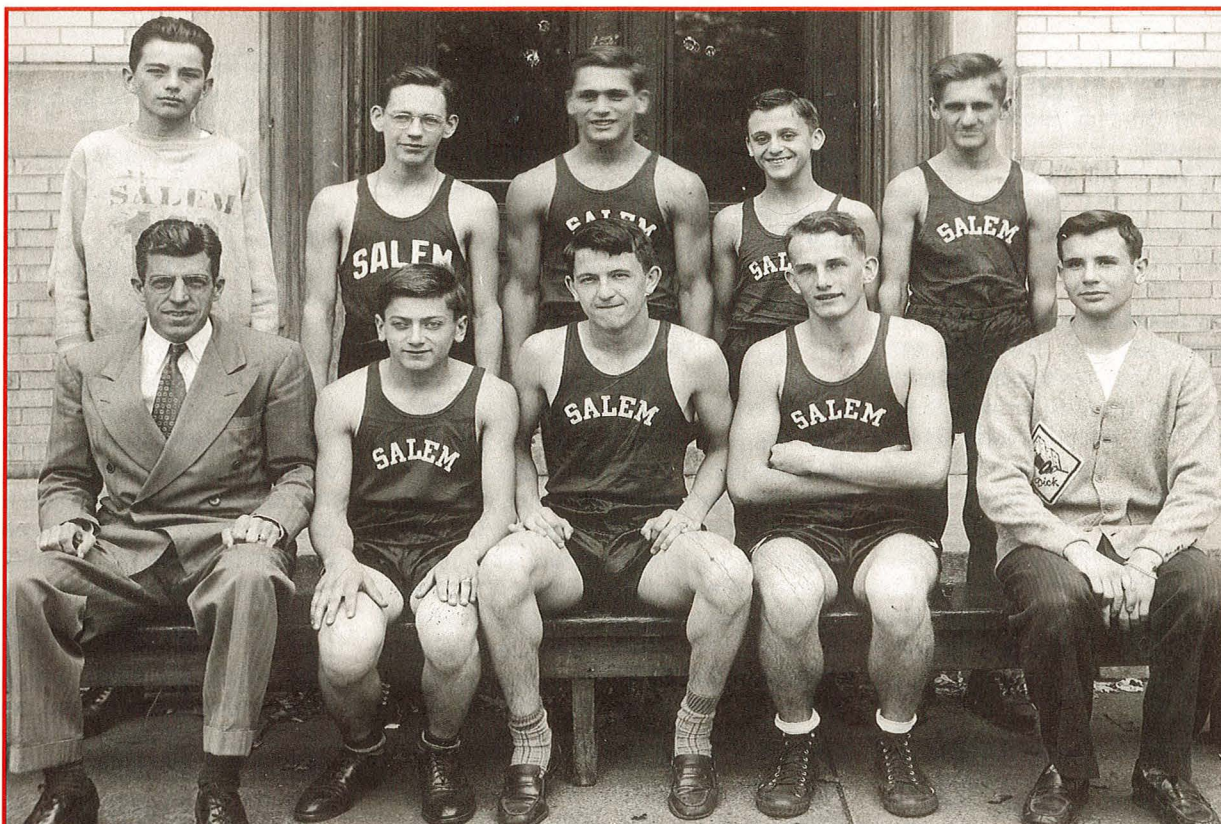
