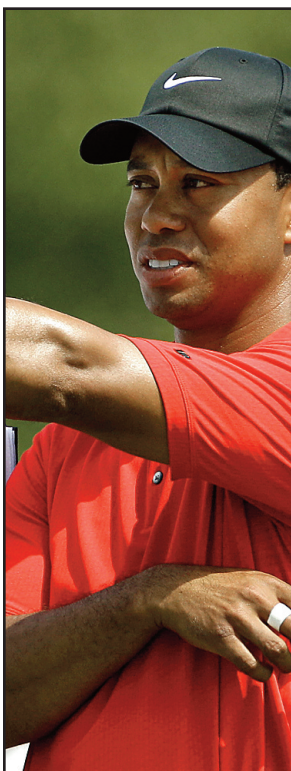

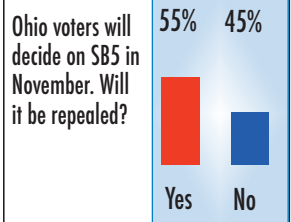

County officially terminates 4 assistance programs

LISBON — Several contracts for public assistance programs that already ended were officially eliminated during action taken at this week's meeting of the Columbiana County commissioners.

Eileen Dray-Bardon, director of the county Department of Job and Family Services, told commissioners three of the four discretionary

programs were eliminated because they were deemed of insufficient value to be continued while federal and state funding is being cut.

The fourth was a subsidized jobs program funded with \$310,000 federal money that expired June 30. This program paid the salary and benefits of income-eligible county residents hired by participating local companies for up to one year. This program created 10

jobs, nine of which were retained as of mid-March.

Dray-Bardon recommended formal elimination of the following contract programs:

— Wrap-Around Service Facilitation, which ended June 30. This program provided special attention to the children of public assistance recipients with multiple issues that need addressed. The program sought to work with the parents

and their children to address these issues.

— Youth Educational/Employment Program, which expired June 2010. This program provided life skills to people from income-eligible households.

— Child Passenger Safety Program, which ended June 30. Clients were taught how to properly install a child car seat.

Salem BOE hires band directors

SALEM — Hannah McFarland was hired as band director and Julie Anne Piatt was hired as the new assistant band director during a special board meeting Friday.

Piatt worked for the school district two years ago and replaces Christopher Rodack who resigned after one year to take a new position in Pennsylvania.

His resignation is effective July 15.

Piatt was hired as the music instructor for the high school, junior high and Southeast Elementary School at the Bachelors 150+ rate.

Cathy Sanor, director of curriculum and federal programs, said the meeting was arranged to hire Piatt because band camp begins Aug. 1.

In other business, the board accepted bids for improvements to the back entrance of the John A. Cabas Gymnasium.

Six bids were received and Foust Construction was the low bid with work beginning as soon as possible, Sanor said.

Foust's low and best bid was \$56,595.

Other bids included Central Allied at \$56,983; E. Mullins Construction at \$59,000; Kreidler Construction at \$61,079; Parrella Pannunzio at \$63,449; and Jim Santini Builders submitted a bid of \$67,170.

Columbiana uses part-time cops to fill in schedule

COLUMBIANA — City Council questioned the effectiveness of hiring part-time police officers at its meeting Tuesday.

Police Chief Tim Gladis said the part-time officers are "as capable as any of the full-time officers" and help the department resolve scheduling conflicts and compensate less overtime.

At the meeting, council approved the part-time employment of Ashley Vaughn of North Lima, a recent police academy graduate, Zach Jones of Negley, a Columbiana auxiliary police officer and Ray Beaver of East Liverpool, a Mahoning County Sheriff's officer. The police department roster now includes nine part-time and 11 full-time officers. Gladis said the number of part-time officers employed has "no bearing" on how the department operates.

"It's not a good idea to run a department on part-time employees," Gladis said. "But to pay the entire force to work overtime at city events or by picking up extra shifts just isn't realistic. We're able to avoid overworking our officers and save money."

Since becoming chief of police in 2009, Gladis has taken an initiative to reduce the number of overtime hours police officers receive. In June 2009, before Gladis was chief of police, officers were paid for nearly 269 hours of overtime. In June 2010, under Gladis, officers were only paid for 60 hours of overtime. Last year, officers received a total of 1,083 hours of overtime, over 1,110 hours less than in 2009.

However, though they help the department save money, Gladis said many part-time officers have other full-time jobs that can potentially affect their police work.

"With their schedules, they can have limited availability when you need them," Gladis said.

Gladis also questioned the effectiveness of a part-time officer who may have conflicting priorities.

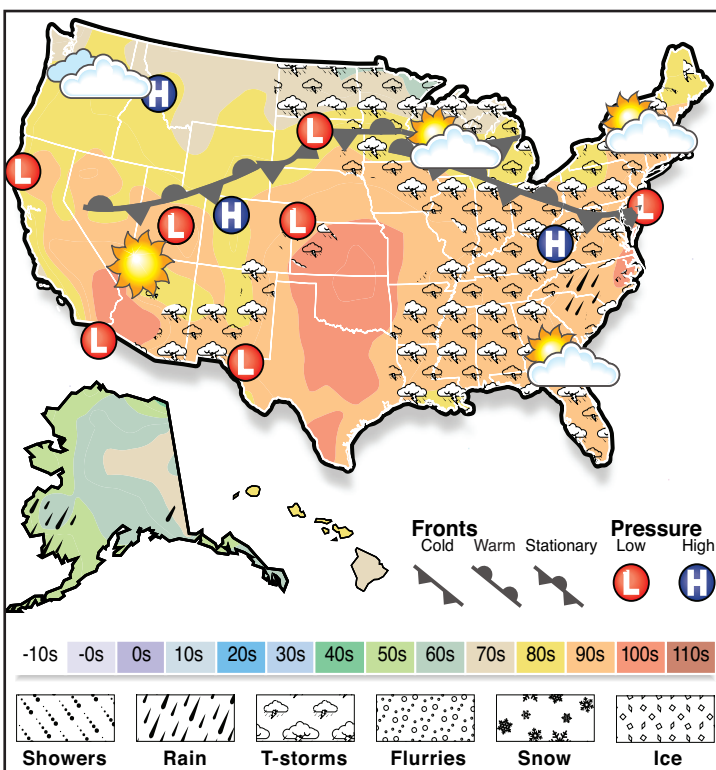

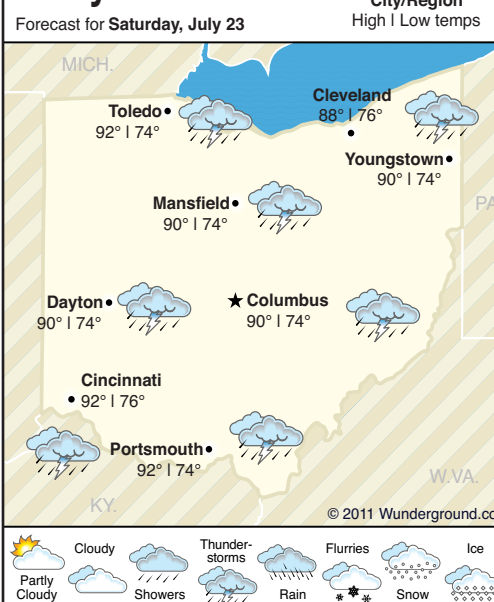

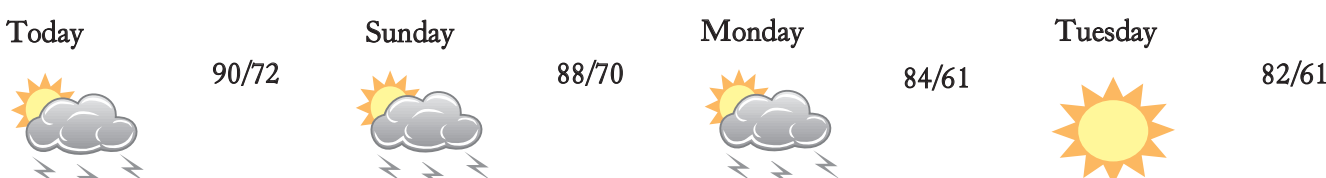

Tree felled after lightning strike

SALEM — There is one less tree in the "Tree City USA" after a lightning strike during Monday's storm forced parks officials to cut down large Red Oak in Centennial Park Friday morning. Parks Foreman Jim Grimm said the 75- to 80-year-old tree was in the center of a six-tree cluster at the park entrance off East Pershing Street. Lightning split the top and ran all the way down to the trunk, Grimm said. "It had a large stress crack," he said, "and Tuesday night's wind caused it to hang up in the Beech tree ... it wasn't a threat until a large section fell into the Beech tree." There were three Catalpa trees and one Linden tree nearby that weren't damaged,

he said. They're fine, not even a sign of lightning," he said. "Generally the Oak trees are taller and their root system is deeper," Grimm said, noting that was possibly the reason why it took the lightning bolt. Trees have been damaged by high winds, but this was the first lightning strike Grimm was aware of in quite awhile. "(It) Goes to show if you're in the park during a storm go under a pavilion." The cluster of trees has been cordoned off and Colian's Multi Service took about two-and-a-half hours to cut the tree down. Grimm said park crews will chip the brush and clean the area up on Monday. Commissioner Mike Halleck wondered whether, with any of these programs they were duplicating services that might be offered through another social service agency. The reason Halleck asked is because he learned from serving on another board there are multiple agencies in the county offering drug and alcohol abuse programs, which seems to him an inefficient way to deliver these services. Dray-Bardon said she is careful in entering into these contracts for discretionary service to ensure they are not already available through another agency.

She said these contracts are designed to address "gaps" in existing services. "I'm very sensitive about trying to avoid that," she said. In other action, commissioners accepted a petition from John Wilms of Salem Township, who is asking an alley that exists only on paper be officially closed. The alley is located behind his property on Lisbon Road, Franklin Square. A public hearing must be held before commissioners can act. tgiambromi@mojonews.com

Why no probe of porn on justice official's computer?

If the Department of Justice finds child pornography on most people's computers, they are in very big trouble. Prosecution and possibly fines and prison time await.

But the rules apparently are different for officials within the government's top law enforcement agency.

U.S. Sen. Charles Grassley, R-Iowa, wants answers about such a situation, from Attorney General Eric Holder. Grassley is the ranking Republican on the Senate Judiciary Committee.

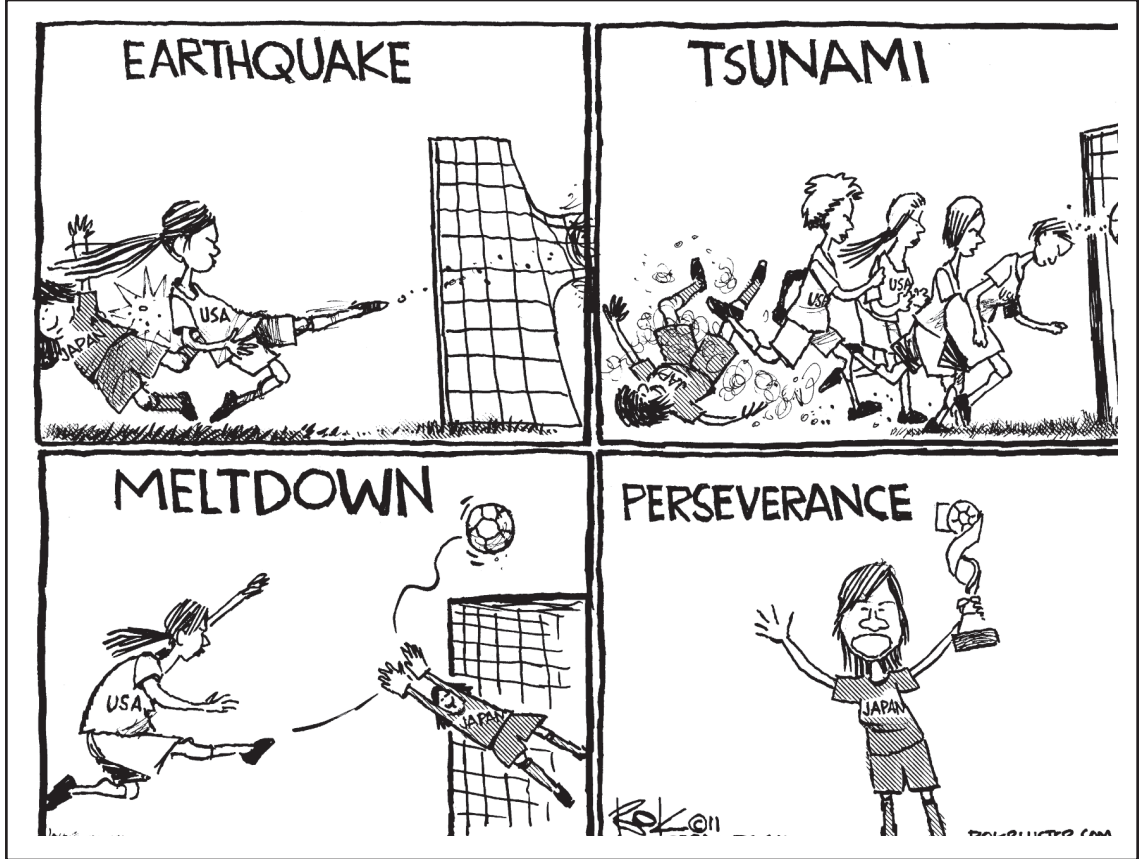
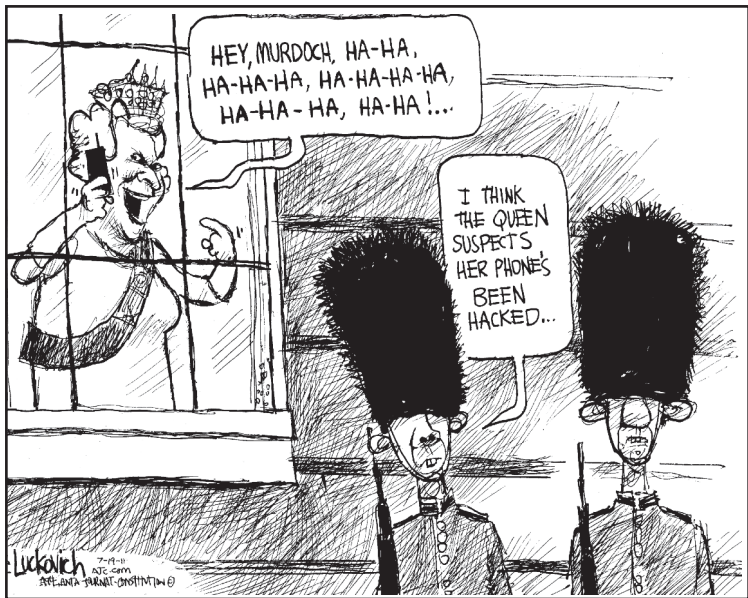
Grassley has written to Holder seeking information about an assistant U.S. attorney who admitted to spending hours using the computer in his government office to view pornography. At least one image of child pornography was found on the computer.

Grassley wants to know why the man, who has not been identified, was not charged with a crime.

That is an excellent question. According to the Justice Department, the official left the agency this spring. No information about whether he was disciplined has been provided to the public.

Again, when the Justice Department becomes aware most people in the United States are in possession of child pornography, criminal charges are filed swiftly and punishment often is harsh. That is as it should be. Promoting child pornography in any way, including being a customer of the perverted business, should be punished.

So why were no charges filed against the former assistant U.S. attorney? Perhaps there was an acceptable reason, but it has not been put forth. Grassley is right to insist on an explanation.



Ministers of culture, agitprop

Immediately after President Obama took office, his Hollywood benefactors clamored for the creation of a "Secretary of Culture." Tinseltown was disappointed with the administration's crony arts czar choice (Chicago lawyer Kareem Dale), but left-wing artists and entertainers have now been mollified.

Instead of one government-supported arts czar, the White House has designated an entire herd of them.

On Tuesday, as part of Obama's "Winning the Future" initiative, the president designated members of the liberal activist group Creative Coalition as official "America's Champions of Change for the Arts." This is the latest in a series of "public engagement" efforts overseen by Obama senior adviser Valerie Jarrett and her high-paid, tax-funded staff of thinly veiled campaign workers operating out of 1600 Pennsylvania Ave.

Honored guests at the event included ardent Obama supporters and Hollywood stars such as Patricia Arquette, Omar Epps, Minnie Driver and Rachael Leigh Cook. Creative Coalition CEO Robin Bronk crowed in a p.r. release: "Rarely before in the history of our country has change been more important, so we are proud to be recognized as a 'Champion of Change.' By sharing our ideas on the arts and arts education with the Obama administration, we can ensure the next generation of Americans have the same opportunities to express their creativity."

Ignore the high-minded talk of artistic free speech. This is nothing more than a Celebrity Rewards Program masquerading as cultural "dialogue" (or, more accurately, echo chamber chatter).

When the Creative Coalition -- comprised of some of the entertainment world's most zealous and wealthy Obama donors -- talks of the need to "make the arts a topic of priority," it means massively increased funding for the National Endowment of the Arts and National Endow-

ment for the Arts. It means using the power of government to turn artists and entertainers into Obama policy lobbyists. And it means buying access not for "ordinary Americans," but for the out-of-touch elitists who use all public channels and platforms to denigrate traditional values and principles.

The Creative Coalition is the group that threw the swankiest inaugural parties for Obama, studied with producers, actors, directors and writers. The Creative Coalition/Obama galas included a lavish inaugural party sponsored by Moët & Chandon, which passed out big fat bottles of pricey wine sporting customized "Obama is the Man" labels. (Quick, someone alert that crazy Rutgers professor who attacked GOP Rep. Paul Ryan over his beverage choices.) They clamored for \$50 million in stimulus pork and still want more.

Members of the Creative Coalition were also entangled in the 2009 NEA/White House campaign to recruit 75 artists, musicians, writers and poets as political "counter-narrative" creators during the health care takeover battle. Then-Office of Public Engagement top officials Tina Tchen and Buffy Wicks urged participants to "sustain energy from the election process" and "think through how their networks and organizations can participate in areas such as the arts in education, health care and preventative care, energy and environment, or economic opportunity."

In other words: Not art for art's sake. But art for Obama's sake.

The White House and its "Champions of Change for the Arts" are flirting dangerously with an Orwellian-style Ministry of Arts Agitprop akin to Europe's and China's. America doesn't need ideologically skewed keepers of the culture in government-sanctioned positions espousing what's best for readers', viewers' and listeners' consumption -- and using tax dollars to shape our tastes and politics. The best way for this White House to stimulate free, unfettered conversation about the arts is to butt out of it.

Herman Cain: A businessman for president?

Herman Cain has an impressive record in the business world. He was a successful vice president at Pillsbury and Burger King, then he turned around the failing Godfather's Pizza.

Is that the kind of person the country needs as president? Cain thinks so.

I spoke with Cain last week.

As a businessman, Cain saw firsthand the harm that government interventions like the minimum-wage inflict. People lose their jobs without even realizing why.

"If the government were to mandate an increase in minimum wage today ... it would simply drive the unemployment rate even higher."

How would he deal with the debt problem?

"We will not default ... (P)ay the military people and their military families, make sure we pay the interest on debt, pay Medicare bills, and then make sure we pay the Medicaid bills. (E)verything else should be on the

table."

Cain says government is not only too big -- it's too complex. To change that, he said congressional bills should be no more than three pages. He's taken a ribbing on that from Jon Stewart

"(T)hree pages was a number to exaggerate a point. Make sure bills are short enough and understandable enough for the American people to understand."

On other matters, Cain can be ambiguous -- special tax treatment for corn-based ethanol, for example.

"(M)ake sure the farmers who are dependent upon ethanol subsidies have the proper alternative distribution for the product."

How can a defender of free markets say that?

"Once you help the farmers get their products to market all over the world, they won't need those subsidies and the free market principles will perform much better because then we should allow ethanol, methanol and all sources to compete in the marketplace."

He also supported TARP bank bailout.

"I looked at the financial meltdown. That was one of the worst situations that I have ever seen, and we need(ed) to do something drastic. But when the administration started to pick winners and losers, I did not agree with the im-

plementation."

He opposed the bailouts of Chrysler and General Motors.

While Cain says he wants less government, he also supports bans on abortion and gay marriage, and the war on drugs. The failure of the war on drugs is obvious to me. I wondered why he didn't see it.

"First, get serious about restricting the amount of illegal drugs coming into this country. ... I refuse to accept defeat by simply legalizing it."

To me, that wouldn't be accepting defeat. That would be proclaiming individual liberty.

On war and peace, Cain has sounded evasive. When asked about Afghanistan during the first presidential debate, he said: "The experts and their advice and their input would be the basis for me making that decision. I am not privy to a lot of confidential information." On my show, he said, "(S)ince that debate, I have begun to develop some perspective on those issues."

So should we get out or stay?

"(T)he surge was working, but this president decided to start drawing troops home. ... (T)he two worst things that we can do is leave too soon if we can win, if we define winning."

Can we define winning?

"That is why I have to talk to the ex-

perts because the United States interest is not clear. ... (U)ntil I have a clear definition of what winning means for the United States of America, I will not shoot from the lip."

The political class mocks Cain for seeking the presidency -- despite never having held public office. I say: What's so great about political experience? All that means is that you are skilled at sucking up to people, smiling when you don't mean it and promising everything to everyone.

I would rather have a businessman as president than a career politician, although government must never be compared to a business, because unlike a company, government gets its revenue by force. Let's also remember the real problem is that government intrudes in matters outside its proper sphere. Not even a great businessman could make that work.

1,400 feet of Reilly Stadium wall, the replication of the original metal gates and brick ticket booth and the addition of a dedication garden with seating and greenery.

The Salem Preservation Society is attempting to raise \$654,000 to cover the cost, through the sale of brick and granite pavers, granite benches, feature trees with plaque, ticket booth sponsorship and platinum, gold and silver sponsorships, along with other fundraising efforts such as the Bob Evans Community Fundraiser event.

In a press release, SPS Reilly Project Steering Committee member David Schwartz said the restaurant fundraiser "is an easy way for all Salem area people that have ever used or attended events at Reilly Stadium to give back a little so others may enjoy future memories of a great and beautiful stadium."

The project got off the ground in March after members of the Salem school board approached the Salem Preservation Society to help with a campaign to save the deteriorating wall at the stadium.

According to the press release, David Sommers Associates of Kent was the architectural firm chosen for the project aimed at restoring the wall. David Sommers graduated from Salem High School in 1967 and is familiar with the wall at Reilly from his school days.

In the press release, Schwartz said the SPS doesn't want the wall replaced by a chain link fence, but "wants to preserve what can be preserved of our great community landmarks."

Cleveland man convicted of murder in 11 deaths

CLEVELAND (AP) — A man who lived among the rotting remains of 11 women was convicted Friday of killing all of them, bringing closure to a case that has haunted the city of Cleveland ever since the bodies were unearthed from a house that smelled like death.

Anthony Sowell, 51, was convicted of aggravated murder, kidnapping, tampering with evidence and abuse of a human corpse in the 11 deaths. He now faces a possible death sentence.

"We do deserve this justice," said Denise Hunter, whose sister, Amelda, was found buried in Sowell's back yard in plastic garbage bags. "I'm so glad that finally, on July the 21st, that all of our families can rest assured — and all of our loved ones can rest assured — that peace has come to our families."

Most of the victims' families slipped out a side entrance of the courtroom, preferring to avoid making any comment about the ver-

dict. When Sowell was convicted of murdering Tonia Carmichael, who was strangled with an electrical charger, Carmichael's mother and daughter clung to each other and wept as they rocked back and forth in the front row.

The jury deliberated for just over 15 hours before announcing the verdicts.

Sowell, dressed in a gray polo shirt and dark slacks, closed his lips tightly, looked straight ahead and barely moved as the first aggravated murder verdict was read before deputies immediately handcuffed him. Then he sat down, his chest heaving as he pushed himself back in the chair.

Most jurors avoided looking at Sowell while the judge read the verdicts. Two jurors wiped away tears and others swiveled in their chairs to look at sobbing relatives of victims.

When the jury left the room, Sowell raised his clasped, cuffed hands high in the air.

None of the attorneys

commented afterward because a gag order remains in place until after Sowell is sentenced. The sentencing phase will begin Aug. 1.

The discovery of the bodies was an embarrassment for the city's police force, which was accused by victims' families of failing to properly investigate the disappearances because most of the women were addicted to drugs and lived in an impoverished neighborhood. In the wake of public outrage over the murders, a panel formed by the mayor recommended a complete overhaul of the city's handling of missing person and sex crime investigations.

Several victims' families filed a wrongful death lawsuit against the city last year.

Cleveland Mayor Frank Jackson's niece, Lori Frazier, was Sowell's ex-girlfriend and testified during the trial. Jackson said in a statement Friday that he hoped the verdict brings closure for the victims' families.

"You have to question, is someone going to be as aggressive to make an arrest or write a citation if they know they're going to have to miss hours for your full-time job to go to court?" he asked.

Gladis said he has never had such a problem with any officer on his police force and said if the situation did arise, "They would be fired immediately."

Gladis said the part-time officers go through the same screening process as the full-time officers, and many were former city explorers or auxiliary officers.

"You screen the ones you don't know, and you maintain control over the development process of the others from the beginning, to ensure a better product," Gladis said of the process.

Jobless rates rose in 28 states

WASHINGTON (AP) — Unemployment rates rose in more than half of U.S. states in June, evidence that slower hiring is affecting many parts of the country.

The Labor Department said Friday that unemployment rates in 28 states and Washington, D.C., increased last month. Rates declined in eight states and were flat in 14. That's a change from May, when 24 states reported falling unemployment rates.

Twenty-six states reported a net gain in jobs in June, while 24 states lost jobs.

The changing trend in state unemployment rates reflects a weaker economy hampered by high gas prices and lower factory output. Nationally, employers added only 18,000 net jobs in June, the second straight month of feeble hiring. The U.S. unemployment rate ticked up to 9.2 percent.

GE second-quarter profit up 21%

NEW YORK (AP) — When it comes to weathering a sluggish economy, it pays to have your fingers in a lot of pies.

At least it does for General Electric Co.

The industrial and financial giant has a stake in almost every sector of the economy, from light bulbs and credit cards to windmills. Its mixed bag of business units have propped up the company at different times since the recession. When the real estate meltdown buried GE's lending arm in bad debt a few years ago, its industrial units continued to grow.

This year, it's the other way around.

A rebound at GE Capital has so far offset weaker industrial business this year. The lending unit helped GE boost profits 21 percent in the second quarter to \$3.76 billion.

GE reported second-quarter earnings to 35 cents per share for the three months ended June 30. That compares with \$3.11 billion, or 28 cents per share, for the same time last year. Revenue fell 4 percent to \$35.6 billion, in part because of GE's sale of a majority stake in NBC Universal to Comcast in February.

McDonald's sales keep rising

NEW YORK (AP) — McDonald's said Friday that its net income rose 15 percent in the second quarter as it continues to entice customers to buy new menu items even as the sluggish economy forces them to cut back spending in other areas.

McDonald's Corp., the world's largest burger chain, has consistently outperformed its fast-food peers throughout the recession and its aftermath even though it raised prices this year. It's also working hard to give customers more reasons to visit it instead of rivals like Starbucks or higher-end burger restaurants.

The company is upgrading its restaurants, offering wireless access, expanding the number of locations with 24-hour service, introducing healthier food like oatmeal and smoothies, and selling fancy coffee

drinks. It's also testing changes to improve customer service, such as sending an employee to walk through the drive-thru and punch orders into a hand-held device.

Verizon pulls in subscribers with iPhone

NEW YORK (AP) — Verizon Communications Inc. is seeing a big boost from the iPhone, adding more new subscribers on contracts in the second quarter than it has in two and half years. Yet AT&T Inc., which has been the exclusive seller of Apple Inc.'s iconic phone in the U.S. until February, still activates three iPhones for every two Verizon does.

When posting a profit for the second quarter on Friday, Verizon also said Chief Operating Officer Lowell McAdam will take over from long-time CEO Ivan Seidenberg, 64, on Aug. 1. The company has signaled the succession for the past year. McAdam, 57, is the former head of Verizon Wireless.

Seidenberg will remain chairman of the company. He became the CEO of Bell Atlantic in 1998. It changed its name to Verizon in 2000 after a major acquisition.

Verizon added 1.26 million wireless subscribers under contract in the April to June period, a result that flies in the face of the slowdown in new subscribers across the industry in the last two years. Since nearly everyone already has a cellphone, gaining new subscribers is chiefly a matter of luring them over from other carriers.

Verizon activated 2.3 million iPhones, well below the 3.6 million AT&T reported for the same period. Verizon sells only the iPhone 4, starting at \$200, while AT&T also sells the older iPhone 3GS for \$49.

AP source: Apple considering Hulu bid

SAN FRANCISCO (AP) — Apple Inc. is in talks to potentially bid for video-streaming service Hulu, a person close to the situation said Friday.

The person, who said Apple is among several companies interested in Hulu, spoke on condition of anonymity because they are not authorized to talk about the matter. In early July, search giant Google Inc. was said to be among about a dozen companies in talks to potentially buy Hulu. Yahoo Inc. is also believed to be interested.

Hulu, which is owned by Disney, News Corp., Comcast Corp. and Providence Equity Partners, started presenting its financial information to interested bidders late last month, after an unsolicited offer prompted its board to look for other offers.

The online video service streams movies and TV shows from broadcasters ABC, Fox and NBC to computers and — for a monthly fee — to a number of Web-connected mobile devices such as smartphones and tablet computers. It expects its paid service, Hulu Plus, to have over a million subscribers by the end of the summer and its CEO, Jason Kilar, has said it is profitable.

Boom in corporate profits, a bust in hiring, wages

WASHINGTON (AP) — Strong second-quarter earnings from McDonald's, General Electric and Caterpillar on Friday are just the latest proof that booming profits have allowed Corporate America to leave the Great Recession far behind.

But millions of ordinary Americans are stranded in a labor market that looks like it's still in recession. Unemployment is stuck at 9.2 percent, two years into what economists call a recovery. Job growth has been slow and wages stagnant.

"I've never seen labor markets this weak in 35 years of research," says Andrew Sum, director of the Center for Labor Market Studies at Northeastern University.

Wages and salaries accounted for just 1 percent of economic growth in the first 18 months after economists declared that the recession had ended in June 2009, according to Sum and other Northeastern researchers.

In the same period after the 2001 recession, wages and salaries accounted for 15 percent. They were 50 percent after the 1991-92 recession and 25 percent after the 1981-82 recession.

Corporate profits, by contrast, accounted for an unprecedented 88 percent of economic growth during those first 18 months. That's compared with 53 percent after the 2001 recession, nothing after the 1991-92 recession and 28 percent after the 1981-82 recession.

What's behind the disconnect between strong corporate profits and a weak labor market? Several factors:

— U.S. corporations are expanding overseas, not so much at home. McDonald's and Caterpillar said overseas sales growth outperformed the U.S. in the April-June quarter. U.S.-based multinational companies have been focused overseas for years: In the 2000s, they added 2.4 million jobs in foreign countries and cut 2.9 million jobs in the United States, according to the Commerce Department.

— Back in the U.S., companies are squeezing more productivity out of staffs thinned out by layoffs during Great Recession. They don't need to hire. And they don't need to be generous with pay raises; they know their employees have nowhere else to go.

— Companies remain reluctant to spend the \$1.9 trillion in cash they've accumulated, especially in the United States. They're unconvinced that consumers are going to spend again with the vigor they showed before the recession, and they are worried about uncertainty in U.S. government policies.

"Lack of clarity on a U.S. deficit-reduction plan, trade policy, regulation, much needed tax reform and the absence of a long-term plan to improve the country's deteriorating infrastructure do not create an environment that provides our customers with the confidence to invest," Caterpillar CEO Doug Oberhelman said.

Caterpillar said second-quarter earnings shot up 44 percent to \$1.02 billion — though that still disappointed Wall Street. General Electric's second-quarter earnings were up 21 percent to \$3.76 billion. And McDonald's quarterly earnings increased 15 percent to \$1.4 billion.

Still, the U.S. economy is missing the engines that usually drive it out of a recession. Carl Van Horn, director of the Center for Workforce Development at Rutgers University, says the housing market would normally revive in the early stages of an economic recovery, driving demand for building materials, construction workers and appliances. But that isn't happening this time.

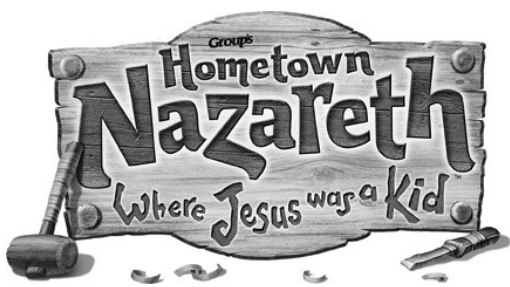

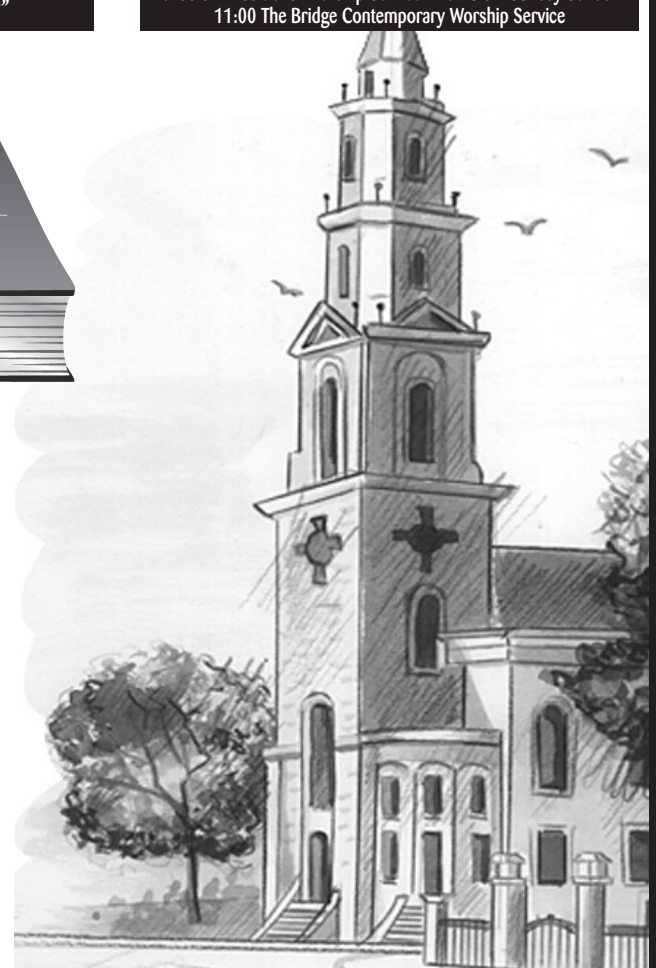

Water walking good exercise, spares joints

DEAR DR. DONOHUE:

One way of exercising that you haven't mentioned is water walking. This puts less strain on joints. You can wear weights on the lower legs. I purchased the weights online. -- N.L.

ANSWER: Water exercises, including water aerobics, are a terrific way to improve strength, lose weight and restore balance while

sparing joints. Everyone can do them -- the older, the younger, women, men, people with arthritis and people recovering from an injury or surgery -- if their doctors agree.

Walking, running and exercising with weights designed for water immersion are only a few of the ways to do this kind of workout. Perhaps the best idea is to join a class with an instructor who can put you through the proper techniques of exercising while in water. Many Y's offer such programs.

You need a flotation belt to keep you horizontal when you are in deep water. Water shoes or clean canvas sneakers are another worthwhile purchase for water exercising.

In waist-high water, body weight is only about half of what it is on land. At neck level, it's around 10 percent to 20 percent of land weight. That's still enough weight to challenge your muscles. Besides, water resistance increases the demand of exercising when submerged. A great advantage of this kind of exercise is the lessening of injury should you fall. The water is a cushion. Another advantage is the ability of water to keep the body from overheating.

DEAR DR. DONOHUE: I am in my early 60s and have been physically active all my life. I have a problem with under-the-arm skin flaps. I play tennis three times a week and work out regularly, but my arms look atrocious. The skin hangs. Is my skin losing its elasticity? Will strength training help? -- B.J.

ANSWER: Yours is a common problem that comes from a loss of skin elasticity, shrinkage of the triceps muscle on the back of the upper arm and a deposition of fat in that area. Triceps exercise will help some. Plastic surgery to sculpt the upper arms is the answer, but an extreme one.

Co-ed fears past will haunt college future

DEAR ABBY: In the past, I made several seriously awful decisions about guys. I also spent two years in high school off and on with a young man who only made my life dramatic and exhausting. Now that I'm a freshman in college, I have encountered several guys I'd love to have a relationship with, but I feel unworthy.

Because of my bad decisions and the fact that I knew these guys before they attended school with me here, I'm worried my past will catch up with me and they'll think I'm still the way I was back then. I have been working on cleaning up my language, and I have sworn off drugs and alcohol trying to make myself more appealing.

Some of my friends have told me I shouldn't have to change who I am for "some guy." Are they right? What should I do to make a connection with one of these young men? -- UNDESERVING IN IDAHO

I believe in the philosophy of constant self-improvement. When you improve yourself to the point that you are proud of yourself, you will attract men who have more to offer than the ones you were involved with in high school.

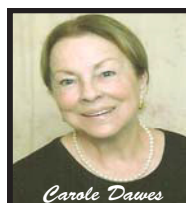

OSU eludes charge

NCAA won't hit school with 'failure to monitor'

The NCAA has told Ohio State that it won't face the most severe charges possible in the memorabilia-for-cash and tattoos scandal that cost football coach Jim Tressel his job.



Investigators said they found no evidence that Ohio State failed to properly monitor its football program or any evidence of a lack of institutional control, according to a letter sent to the university and released Friday.

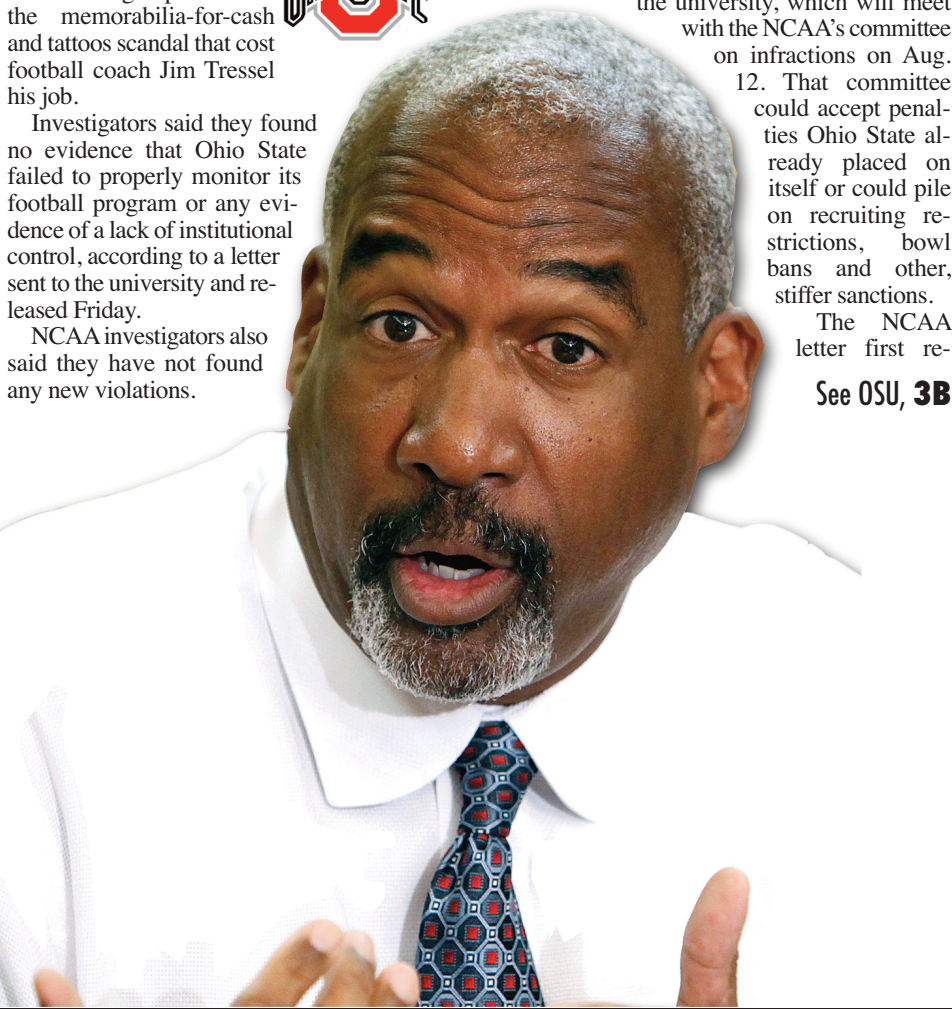
NCAA investigators also said they have not found any new violations.

"Considering the institution's rules education and monitoring efforts, the enforcement staff did not believe a failure to monitor charge was appropriate in this case," the NCAA said in the letter sent Thursday.

The notice clearing Ohio State of the most serious of institutional breaches is a big break for the university, which will meet with the NCAA's committee on infractions on Aug. 12. That committee could accept penalties Ohio State already placed on itself or could pile on recruiting restrictions, bowl bans and other, stiffer sanctions.

The NCAA letter first released Friday.

Players study deal OK'd by owners

NFL stuck in a holding pattern

WASHINGTON (AP) — The NFL was stuck in a holding pattern Friday as the players studied the owner-approved proposal to end the lockout and tried to determine when — and even whether — to vote on it.

As it is, clubs already were being told not to expect players to begin arriving at facilities Saturday, the day owners said gates would open.

"Now it's just waiting," Carolina Panthers general manager Marty Hurney said at an Atlanta hotel where team executives were being briefed on new rules for next season. "Be flexible and wait and see what happens."

The two sides were expected to be in contact as they tried to iron out remaining hang-ups preventing a deal. Owners ratified the tentative terms 31-0 — the Oakland Raiders abstained — on Thursday, provided players would give their OK, too, and re-establish their union.

But players decided later Thursday not to hold a vote, saying they hadn't had a

chance to see a finished product.

By Friday, it was in hand. "Player leadership is discussing the most recent written proposal with the NFL, which includes a settlement agreement, deal terms and the right process for addressing recertification," NFL Players Association president Kevin Mawae said in a statement released by the group. "There will not be any further NFLPA statements today out of respect for the Kraft family while they mourn the loss of Myra Kraft."

NFLPA head DeMaurice Smith attended Friday's fu-

Calcavecchia, Rinker lead charge at Senior Open

Tom Watson six shots back

WALTON ON THE HILL, England (AP) — Americans Mark Calcavecchia and Lee Rinker had a two-shot lead after the second round of the Senior British Open on Friday.



Calcavecchia — one of three overnight leaders — made six birdies in his 3-under 69. He was joined at 7 under by Rinker and Canada's Rod Spittle, who each shot 67 at Walton Heath.

It's the first time since 2004 that at least three players have held a share of the lead after 36 holes of a Senior British Open.

Australian Peter Fowler was two shots back after a 68, with American pair John Cook (67) and Mike Goodes (70) tied at 4 under. Defending champion Bernhard Langer faded with a 76, nine shots off the pace.

Fowler, a two-time winner on the Senior European Tour this season, holed a pitch shot for birdie on No. 16. England's Kevin Spurgeon had the low round with eight birdies for a 66.

Bob Tway (70) and 2010 runner-up Corey Pavin (72)

were tied at 3 under with England's Barry Lane (70).

Tom Watson had a bogey-free 68 to move into contention at 1 under, along with Mark O'Meara and Tom Lehman, who each had a

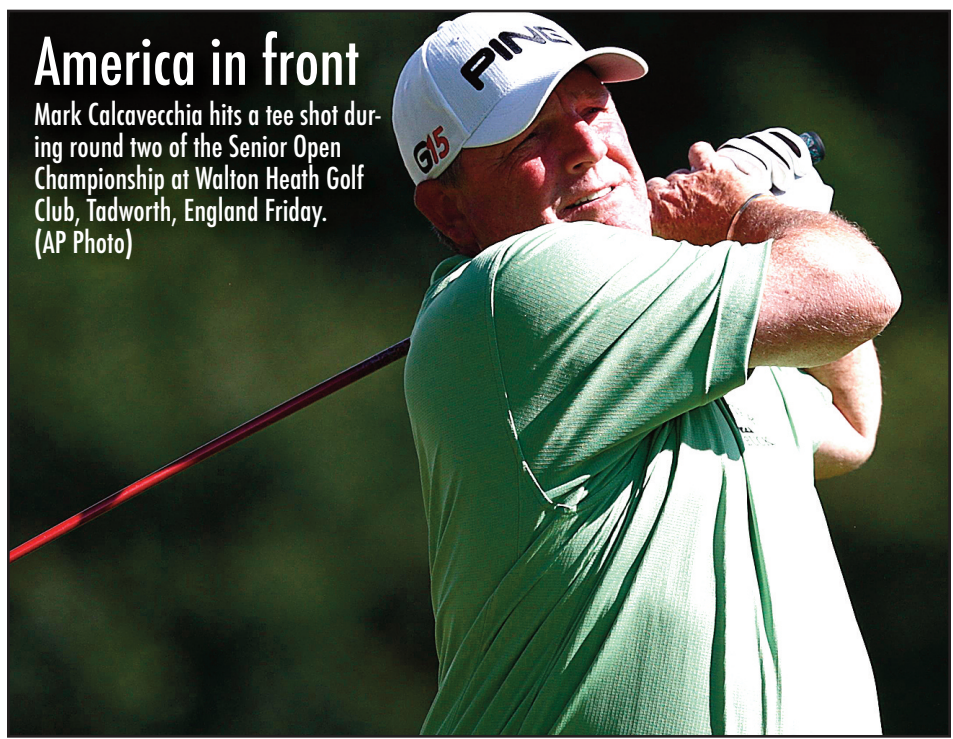
72. Americans filled six of the top nine places, improving the likelihood of an eighth U.S. winner in nine years.

Australia's Mike Harwood and Zimbabwean-born Mark McNulty shared the overnight lead with Calcavecchia, but finished at 74 and 76, respectively.

Calcavecchia and Rinker live near each other in Jupiter, Fla., and grew up playing junior golf together. However, their careers have taken different paths.

While the 50-year-old Rinker doesn't have a career victory, Calcavecchia is best known for winning the British Open at Troon in 1989 and has 12 more wins on the PGA tour.

Calcavecchia is bidding to become the fourth player — after Watson, Gary Player and Bob Charles — to achieve the

British Open double.

"That would be awesome company to keep. They're three Hall of Famers. That would be really special," Calcavecchia said.

Rinker, in his first season on the Champions Tour, only sealed his spot at Walton Heath with a top-10 finish last month at Endicott, N.Y. He had five

birdies in a blemish-free round.

"It's been a long time since I've been in this position," said Rinker, whose best showings were two second places in 1997. "But my game's been coming along this year. We'll see how I hold up."

Spittle joined the American pair atop the leaderboard toward the end of the round, fin-

ishing with six birdies in the last 10 holes.

Langer had a double bogey on the par-4 No. 4, adding to three other dropped shots.

However, the two-time Masters champion made the cut, which came at 4 over. American amateurs Paul Simson (2 over) and Randy Haag (3 over) also made the cut.

Saiki lead Evian Masters, Stanford trails by 1, Creamer by 2

EVIAN-LES-BAINS, France (AP) — Miki Saiki of Japan took a one-stroke lead at the Evian Masters on Friday, shooting a 5-under 67 in the second round to move to 9 under as the drenched course started to dry.



Saiki leads Americans Angela Stanford, whose 66 included seven birdies, and Kraft Nabisco winner Stacy Lewis (67). Also challenging at 8 under are former Evian champion Ai Miyazato of Japan, who finished with a 68, co-overnight leader Maria Hjorth of Sweden (69) and South Korea's Ahn Shin-ae (69).

"From yesterday, I was hitting the ball really well and it kind of continued today," Saiki said through a translator. "Yesterday there was a lot of rain and you didn't know what you were going to get. Today you had no wind, the greens were consistent."

Paula Creamer (67), Cristie Kerr (69) and Karen Stupples (70) were two shots behind the leader. Kerr had an eagle on the ninth and followed with a birdie on 10.

Stanford's plan was to attack from the outset.

"Before we went out (we) realized the course could be scoreable with some of the pin placements," Stanford said.

Lewis picked up her form after going

3-over in the last four holes at the end of her rain-soaked first round Thursday. Starting the day at 3 under, the Lewis decided she would take a positive attitude and finished with seven birdies.

She wrote a single word on her glove to cheer herself up.

"I just wrote 'confident.' Just to trust what I'm doing," she said. "I just started making birdies and putts." Ahn was pressuring for a share of the lead again until she hit a wild tee shot into the rough on the 18th, managing par.

Creamer was only 18 when she beat 15-year-old Michelle Wie to win at Evian in 2005. She has not won it since, and admits that early success resulted in unrealistic expectations.

"Every year I've come back and I've expected myself to do it over and over again," she said. "In reality, I put a little too much pressure on myself."

Meanwhile, Wie shot 73 and missed the cut at 5 over, despite birdies on the last two holes.

always given, just in tweet form.

We've never gotten humility from Tiger and we never will. His ego is so inflated a cloud of smug practically appears on the weather radar above his Florida community.

Even when he's doing "good" by contributing to charitable organizations, no one is walking away feeling warm and fuzzy. When guys like Phil Mickelson contribute to charity, it seems genuine and heartfelt. When guys like Woods contribute to charity, it seems forced and fake.

When Woods stiff's car valets and bellhops consistently, how hard must it be for him to un-sew his own wallet and give money to kids in need? But even then little of the money is coming directly from golf's former icon. The money comes from his star power. Have Woods, will donate. And the businesses line up one after another to contribute to his charitable funds. It's all well and good he's able to garner that support for simply being who he is, but Tiger seems about as genuine as a Louis Vitton handbag purchased from a dodgy character in a shady van in a back alley.

Everything Woods has done since two Thanksgivings ago is contrite and narcissistic. His apologies. His staged press conferences. His timed interviews. His last-minute withdrawals from tournaments he knows very well he doesn't have a chance to play in.

All of Tiger's decisions are done in a manner to keep attention firmly on him. He dismisses his peers' advice. Lee Trevino and Rocco Mediate for starters, have both said Woods' swing and the pressure he puts on his left knee is exactly what's led to four surgeries and an Achilles problem. Woods scoffs at it. He's stayed with his swing coach Sean Foley, a coach Woods has won

exactly zero tournaments with, and then has constantly criticized his former swing coach Hank Haney. When Haney and Woods were a pair, Woods was a wrecking machine wherever he went. The only thing he's wrecked since firing Haney was his SUV.

He fired his caddie Steve Williams. Williams was such an adamant supporter of his golfer he screamed at photographers and chucked cameras into ponds. He didn't mutter a word when Tiger's scandal hit, and he even ripped Tiger's once biggest rival in Mickelson publicly. Williams seemed to be Tiger's only ally for nearly two years. He was sacked for his loyalty in another move where Woods was too self-centered to place any blame on himself. It's his ex-wife's fault. It's the mistresses' fault. It's the swing coaches' fault. It's the caddies' fault. It's the fault of everyone but Tiger.

Woods is sports' ultimate pansy. He never owns up to anything. He never takes advice from anyone around him that isn't a yes-man. He's forever had an inflated sense of himself, but in the past his talent on the golf course overshadowed his personal faults.

Not anymore. Tiger lives in the highest of towers on the tallest of perches. His peon friends on the PGA Tour don't have any clue what they're talking about, so certainly none of us regular peons would even have a shred of credibility.

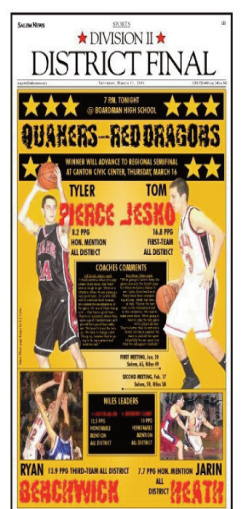

Floyd, Quentin lead Sox past Indians 3-0

Tribe falls to a game out of first place

CLEVELAND (AP) — Gavin Floyd allowed four hits over 7 2-3 innings and Carlos Quentin hit a three-run homer in the fifth to give the Chicago White Sox a 3-0 victory over the Cleveland Indians on Friday night.

Floyd (8-9) earned his second straight win after going 0-4 over six previous starts. The right-hander struck out five and didn't issue a walk for the first time in 19 starts.

Quentin's 20th homer came off Carlos Carrasco (8-8).

Sergio Santos, the second Chicago reliever, struck out Matt LaPorta on a pitch in the dirt with a runner on second in the ninth for his 19th save in 22 chances to complete the five-hitter.

Matt Thornton replaced Floyd with runners on second

and third in the eighth. Pinch-hitter Orlando Cabrera drove his first pitch toward the gap in left-center, but left fielder Juan Pierre made a running catch near the warning track to end Cleveland's best scoring threat.

Thornton gave up a single to Michael Brantley in the ninth, then struck out Asdrubal Cabrera and got Travis Hafner to line out to center before yielding to Santos.

Chicago improved to 12-20 against AL Central opponents by winning for just the sixth time in its last 15 games overall. The second-place Indians have lost five of seven and are 3½ games ahead of the White Sox.

Carrasco worked out of several early jams, stranding two runners in both the first and second innings and leaving the

bases loaded in the third.

Quentin ended that in the fifth. Paul Konerko and Adam Dunn reached on one-out singles before Quentin belted a 2-1 pitch into the bleachers in left for the game's only runs.

Quentin is a key reason why the White Sox are 5-1 this year against Cleveland. He is batting .500 (11 for 22) with three homers and 12 RBIs in the season series.

Floyd retired the first nine Indians. Ezequiel Carrera led off the fourth with a single, but was erased on a double play that featured some fine fielding by Chicago. First baseman Konerko scooped up a sharply hit ball by Brantley at his ankles and threw to shortstop Alexi Ramirez to force Carrera. Ramirez then sidestepped the sliding runner, jumped up and threw to first, where Floyd dug out the low throw to complete the double play.

Carrasco gave up six hits and three runs over 6 1-3 innings, striking out six. After going 4-2 with a 1.90 ERA in June, the right-hander 0-4 with a 7.40 ERA in four July starts.

Notes: Rain delayed the start 47 minutes. ... Cleveland called up 2B Jason Kipnis from Triple-A Columbus and he went 0 for 2 and was hit on the knee by a pitch in his major league debut. NY Jets' Edwards pleads guilty to DWI

NEW YORK (AP) — New York Jets star wide receiver Braylon Edwards pleaded guilty Friday in his drunken driving case, saying he wanted to resolve it as a possible end to the NFL players' lockout neared.

"I feel good. I feel like it came to a fair conclusion," Edwards said as he left a Manhattan court after pleading guilty to a misdemeanor driving while intoxicated charge. His case will be closed without jail time or probation if he meets conditions that include paying a \$500 fine and staying in an NFL substance abuse counseling program he's been in since October.

"We're happy that it's past us, and now it's really time to focus on football again," he

said. His drivers' license will be suspended for six months, and he'll have to install a device that prevents a car from starting until the driver blows into a breath alcohol detector. He's due to check in with the court in October.

The plea came as the prospect of free agency looms for the 28-year-old wide receiver, who reiterated Friday that he "most definitely" wants to stay with the Jets. NFL owners approved a proposal Thursday to end the labor impasse and four-month-long lockout, but players have not yet voted.

It's unclear whether Edwards might face a league suspension over his DWI plea, or how it might affect his probation in Cleveland, where he pleaded no contest in January 2010 to misdemeanor aggravated disorderly conduct. Ed-

wards, who was with the Cleveland Browns before being traded to the Jets in October 2009, had been accused of punching a friend of NBA star LeBron James outside a nightclub.

A spokesman for the Jets, Bruce Speight, said the team is aware of Edwards' plea and due to the "current labor situation" would have no further comment. A Cleveland Municipal Court spokesman didn't immediately respond to messages. Edwards' lawyer, Peter M. Frankel, said he hoped the league and Cleveland authorities would take into account the player's extensive charitable activities, including the \$1 million in college scholarships he awarded Cleveland students this spring.

Edwards was pulled over in Manhattan around 5 a.m. on Sept. 21; police said his Land

Rover's windows were too dark. His four passengers included Jets left tackle D'Brickashaw Ferguson and defensive end Vernon Holston.

Edwards' blood-alcohol level was twice the legal limit, police said. He told an officer he'd had "a couple of drinks," the last about an hour before, prosecutors said at his arraignment last fall.

"We were coming from a party. How about if I just leave the car and take a cab and go home?" he asked, according to prosecutors.

Edwards had challenged the basis for stopping him, the accuracy of the alcohol breath test and other aspects of the case. Edwards had "a very legitimate chance" of prevailing at trial, but with free agency impending, "he wants to put any negativity behind him," Frankel said.

neral in Newton, Mass., for Kraft, the wife of New England Patriots owner Bob Kraft.

Even when players decide they're OK with a final agreement, their approval process is more complicated than the owners' was. The 32 team reps will have to recommend accepting the settlement. Then the 10 named plaintiffs in the players' lawsuit against the league — including Tom Brady, Peyton Manning and Drew Brees — must officially inform the court of their approval.

Eventually, all 1,900 players

would take a majority vote to approve returning the NFLPA to union status. When talks broke down in March, allowing the old collective bargaining agreement to expire, the players dissolved the union, turning the NFLPA into a trade association.

That's what allowed the players to sue the owners in federal court under antitrust law.

Only after the NFLPA is again a union can it negotiate certain parts of a new CBA. Among those items that are of most concern to players:

- the league's personal conduct policy;
- drug testing;
- benefits, such as pension

funds, the disability plan, and the "88 Plan," which provides money for care of former players with dementia or Alzheimer's disease.

The major economic framework for a 10-year deal was worked out a week ago.

That included how the more than \$9 billion in annual league revenues will be divided (about 53 percent to owners and 47 percent to players over the next decade; the old CBA resulted in nearly a 50-50 split); a per-club cap of about \$120 million for salary and bonuses in 2011 — and at least that in 2012 and 2013 — plus about \$22 million benefits; a salary system to rein in spending on first-round draft picks;

and unrestricted free agency for most players after four seasons.

Commissioner Roger Goodell and the owners expressed hope Thursday night that their vote would lead to a speedy resolution to the NFL's first work stoppage since 1987. They called it an equitable deal that improves player safety and allows the sport to prosper even more.

"It is time to get back to football," a weary Goodell said.

Already, one game is sure to be lost: The league called off the Hall of Fame exhibition opener, scheduled for Aug. 7 between the Chicago Bears and St. Louis Rams.

ported by The Columbus Dispatch said that Tressel was the only university official who knew about the violations involving his players. He didn't report them to anyone else at the school.

Ohio State spokesman Jim Lynch said the NCAA's findings were consistent with the university's own investigation into what happened with the allegations surrounding Tressel and the players.

Tressel stepped down under pressure in May, months after the university discovered emails showing he'd been warned by an attorney in April 2010 about his players' involvement with a Columbus tattoo parlor owner. The coach knew players received cash and tattoos for autographs, championship rings and equipment but did not tell anyone at

Ohio State or the NCAA for about nine months. NCAA rules — and Tressel's contract — specified that he had to disclose any and all information about possible violations.

The university announced earlier this month it would vacate the 2010 season, including its Sugar Bowl victory over Arkansas and its share of the Big Ten championship. It also self-imposed a two-year NCAA probation, in addition to suspending six players for the first five games and forcing Tressel out.

Ohio State also will overhaul its compliance office by the end of the year, creating a centralized office that will oversee athletics as well as other university departments, one of its trustees announced Friday. The move will strengthen oversight of all aspects of the university, said trustee Robert Schottenstein.

Shortly after Tressel ended his 10-year run at Ohio State,

which included the 2002 national championship, star quarterback Terrelle Pryor — one of the suspended players — left the school, hoping to try his luck in an NFL supplemental draft.

Tressel met with Ohio State and NCAA officials on Feb. 8 to discuss the allegations. According to a transcript released Friday, he said that he made a mistake by keeping the information from his superiors.

He also said he knew that NCAA sanctions were "inevitable."

"It was pretty simple. We were either gonna be horribly in trouble from a criminal standpoint, or we're gonna be minorly involved in drug, you know, buying and stuff, or we're gonna face the NCAA reality that we did some things with our memorabilia we're not allowed to do," he said. "I was totally confident one of those was gonna happen."

The U.S. attorney's office

notified Ohio State officials last December that it discovered some Ohio State memorabilia during a raid.

That led to the investigation into five players who were suspended, but allowed to participate in the Sugar Bowl on Jan. 4.

Tressel was asked if he would have never come forward if the government had not sent the letter.

"Never is a long time. I don't know," he replied.

"I had confidence in the federal government that they were gonna do what they were supposed to do," he said. "They didn't need my help to do it, nor did they need my interruption to do it."

The NCAA also said in its letter released Friday that it investigated a Sports Illustrated report that said nine more players sold memorabilia to the tattoo parlor owner, but confirmed that only one had any dealings with the man.
