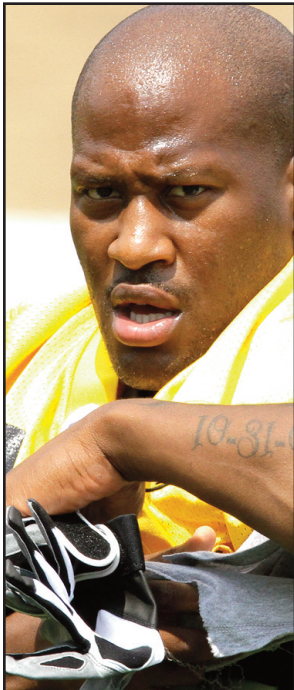

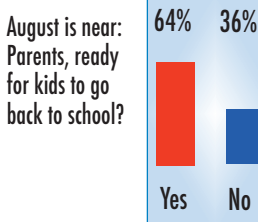

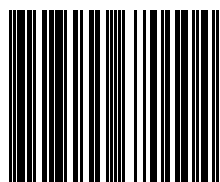

Just 3 show for 'protest'

SALEM — A group opposing what it believes to be proposed cuts in Social Security and Medicare programs met outside U.S. Rep. Bill Johnson's office Friday morning, just hours before Congress was to vote on a debt ceiling plan.

The three protesters gathered outside the office before entering and voicing their disagreement with Speaker of the House John Boehner's plan to raise the national debt ceiling, a plan they claimed will adversely affect local citizens.

"Folks in this community deserve to have some security and dignity in their later years, so to target these types of programs...when people are already struggling is short-sighted and just doesn't make sense to me," said organizer Anthony Caldwell of East Liverpool.

According to a press release issued by Caldwell promoting the event, under the plan, Ohio veterans, seniors and people with disabilities could see major cuts to programs like transportation services, meals on wheels and health care.

"People like to call these 'entitlement programs,'" he said. "They're not entitlements when you've already paid into them."

A representative for Johnson responded to the protest Friday afternoon, noting that much of the fear is unfounded.

"We always appreciate hearing from constituents and are glad to have the opportunity to set the record straight from rumors intended to spread fear and panic to seniors," said Jessica R. Towhey, spokesperson for Johnson. "Congressman Johnson has not supported or voted for any legislation that would cut Social Security or Medicare benefits for seniors. He has supported legislation to reform both

Damascus firefighters, Ruritans raise new flag for post office

DAMASCUS — The flags are flying at the Damascus Post Office once again thanks to the efforts of its community. Nearly a month after the rope holding up the American and POW flags above the facility broke, the Damascus Ruritan Club and the Damascus Volunteer Fire Department, in a joint effort Tuesday night, replaced the rope and raised the flags, which fly day and night.

According to Cathy Willis, officer in charge at the facility, the rope broke on July 4. After calling the Akron post, she said she was redirected to the Cleveland facility.

Since there is only one bucket truck for the entire northeast Ohio region, the Damascus Post Office flag pole was not likely to be replaced soon, Willis said she was told.

A casual conversation with Ruritan Mahlon Griffith initiated the project, and Willis said she received approval to have the community groups do the work.

"It was going to get up a lot quicker," she said. Willis noted everything transpired quickly once the organizations got involved.

"We really appreciate them doing this," she said. "[Damascus was] probably the only post office that didn't have a

BDD sets Aug. 12 open house at new candle facility

LISBON — The wax, the wicks and all the materials needed to create works of candle art have been moved into the new facility of the Columbiana County Board of Developmental Disabilities on County Home Road.

Complete with a lab for pouring candles and a large storage space for both supplies and completed candles, the new EDI-Central facility is climate controlled to allow the candles to properly set. The candles will be created by hand by clients of the county BDD. They will produce candles with various scents and candles resembling delicious pies and muffins.

The new building will give those already creating the candles more space to work. The candles are already for sale on the BDD website, at the administrative offices and have been making appearances at various craft shows.

The BDD board met in the new EDI-Central facility on Wednesday, giving members of the board a chance to see where the new operations will be housed. The plan is to have the move completed in time for the grand opening open house of the new facility set for Aug. 12.

Superintendent Bill Devon told the board those invited to the event include Congressman Bill Johnson and state Sen. Jason Wilson. The public is also invited.

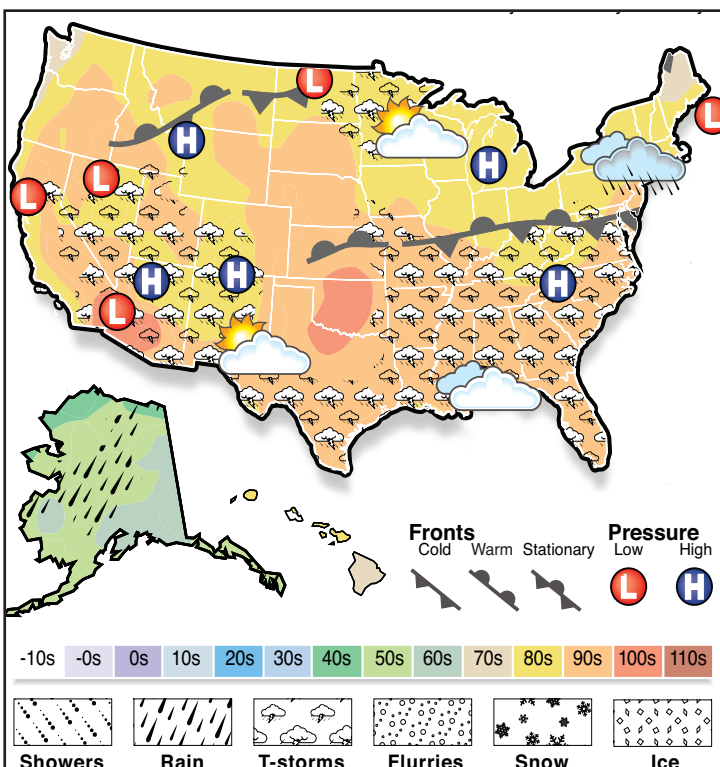

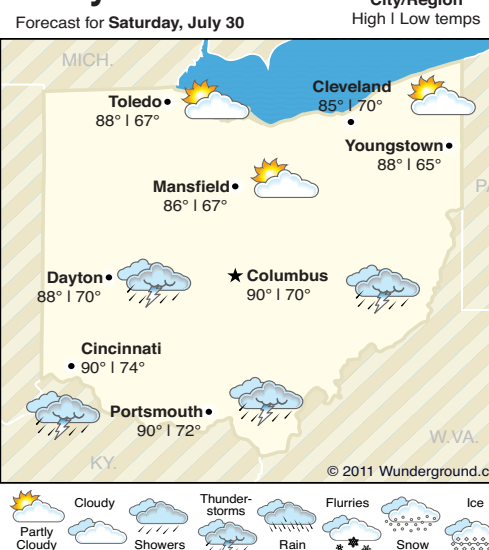

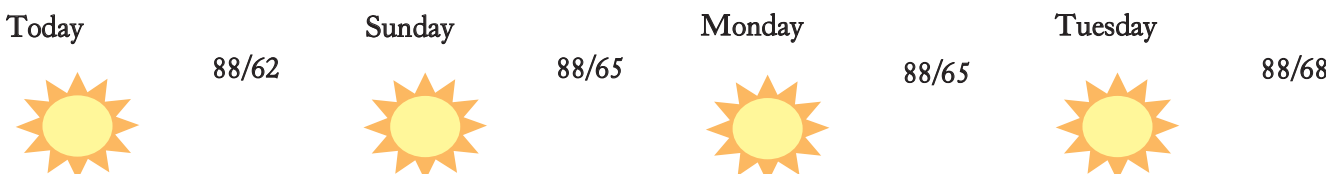

AWOL soldier defiant in court, yells out name of man accused in 2009 shooting

WACO, Texas (AP) — An AWOL soldier accused of plotting to launch an attack on Fort Hood was defiant during his first court appearance on Friday, yelling out the name of the Army psychiatrist blamed in the 2009 deadly shooting rampage at the same Texas base.

Federal prosecutors charged 21-year-old Pfc. Naser Abdo with possessing a destructive device, two days after he was arrested at a motel about 3 miles from the front gate of Fort Hood. He told authorities he planned to construct two bombs in the motel room using gunpowder and shrapnel packed into pressure cookers and then detonate the explosives at a restaurant frequented by soldiers, court documents released Friday said.

Abdo, who had requested conscientious objector status because his Muslim beliefs prevented him from fighting in Iraq and Afghanistan, refused to stand up during Friday's hearing when everyone in the court was asked to rise for the judge.

As he was being led out of the courtroom, he yelled out "Iraq 2006" and the name of the 14-year-old Iraqi girl who was raped and murdered in 2006 by a U.S. soldier. He then shouted: "Nidal Hasan Fort Hood 2009."

Libya opposition suffers setback as witnesses say military chief killed by fellow rebels

BENHAZI, Libya (AP) — The Libyan rebels' military commander was killed by his comrades while in custody after he was arrested by the opposition's leadership on suspicion of treason, witnesses said Friday, in a sign of disarray that posed a major setback for the movement battling Moammar Gadhafi.

The slaying of Abdel-Fattah Younis raised fear and uncertainty in Benghazi, the de facto rebel capital. Thousands marched behind his coffin, wrapped in the rebels' tricolor flag, to the graveyard for his burial, chanting that he was a martyr "beloved by God." Troops fired a military salute as the coffin arrived, and angry and grieving supporters fired wildly into the air with automatic weapons.

At the graveside, Younis' son, Ashraf, broke down, crying and screaming as they lowered the body into the ground and — in a startling and risky display in a city that was the first to shed Gadhafi's rule nearly six months ago — pleaded hysterically for the return of the Libyan leader to bring stability.

"We want Moammar to come back! We want the green flag back!" he shouted at the crowd, referring to Gadhafi's national banner.

Somali man recalls horrors of jail, rape, death while fleeing country's famine

DADAAB, Kenya (AP) — When al-Qaida-linked militants learned that Ahmedhashim Mawlid Abdi and his family were planning to flee Somalia's famine,

they threw the 40-year-old father of seven in jail for two days.

Over the next 17 days, as they made their escape, a gang of gunmen robbed them of the little food they had, Abdi's pregnant wife was raped in front of him, and his 7-year-old son died of starvation and disease. They were even attacked by a lion.

When they finally made it to the Daghaley refugee camp in neighboring Kenya, their struggles were far from over. Food rations in the overcrowded camp are "just enough to survive on," Abdi said. And the future is uncertain.

As Somalia's famine unfolds in the middle of a war zone, some 2.2 million people are in peril in an area controlled by the al-Qaida-linked al-Shabab that is inaccessible to aid groups.

Norway holds services to mourn 77 victims of bombing and youth camp shooting

OSLO, Norway (AP) — Norway began burying the dead on Friday, a week after an anti-Muslim extremist killed 77 people in a bombing and shooting rampage. Mourners of all ages vowed they would not let the massacre threaten their nation's openness and democracy.

An 18-year-old Muslim girl was the first victim to be laid to rest since the gunman opened fire at a political youth camp and bombed the government headquarters in Oslo.

After a funeral service in the Nesodden church outside the capital, Bano Rashid, a Kurdish immigrant from Iraq, was buried in a Muslim rite. Sobbing youth accompanied her coffin, which was draped in a Kurdish flag.

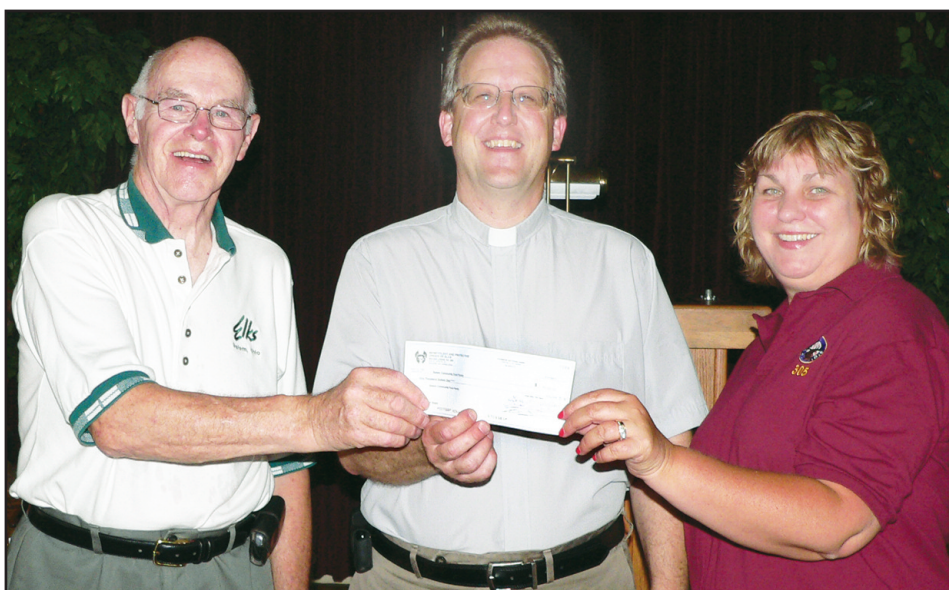
The attack will "not destroy Norway's commitment to democracy, tolerance and fighting racism," Labor Party youth-wing leader Eskil Pedersen said at a memorial service in Oslo. Pedersen, who was on the island retreat of Utoya when the gunman's attack began, said: "Long before he stands before a court we can say: he has lost."

Egypt's ultraconservative Muslims turn out for protest

CAIRO (AP) — Tens of thousands of ultraconservative Muslims in long beards, robes and prayer caps thronged Cairo's central Tahrir Square in a massive show of force Friday, calling for the implementation of strict Islamic laws and sparring with liberal activists over their visions for a post-revolution Egypt.

It was the first rally with religious overtones in Egypt, and one of the largest, since the uprising that forced President Hosni Mubarak to step down in mid-February. The strong showing by the Islamists demonstrated their powerful organizational abilities, which will likely help them in parliamentary elections later this year.

"Islamic. Islamic. Not Western or Eastern. No liberal or secular," chants of Salafis, who follow a strict form of Islam, echoed through the square. Others shouted: "With our soul and blood we defend you Islam."

House approves debt bill; Senate rejects it within hours

WASHINGTON (AP) — In an unforgiving display of partisanship, the Republican-controlled House approved emergency legislation Friday night to avoid an unprecedented government default and Senate Democrats scuttled it less than two hours later in hopes of a better deal.

"We are almost out of time" for a compromise, warned President Barack Obama as U.S. financial markets trembled at the prospect of economic chaos next week. The Dow Jones average fell for a sixth straight session.

Lawmakers in both parties said they were determined to avoid a default, yet there was little evidence of progress — or even significant negotiations — on a compromise during a long day of intense political maneuvering.

The House vote was 218-210, almost entirely along party lines, on a Republican-drafted bill to provide a quick \$900 billion increase in U.S. borrowing authority — essential to allow the government to continue paying all its bills — along with \$917 billion in cuts from federal spending.

It had been rewritten hastily overnight to say that before any additional increase in the debt limit could take place, Congress must approve a balanced-budget amendment to the Constitution and send it to the states for ratification. That marked a concession to tea party-backed conservatives and others in the rank and file who had thwarted House Speaker John Boehner's attempt to pass the bill Thursday night.

"Today we have a chance to end this debt limit crisis," Boehner declared, his endgame strategy upended by rebels within his own party.

But the changes he made to the House GOP bill further alienated Democrats. And they complicated prospects of a compromise that could clear both houses and win Obama's signature by next Tuesday's deadline.

At the other end of the Capitol, Senate Democrats rejected the measure without so much as a debate. The vote was 59-41, with all Democrats, two independents and six Republicans joining in opposition.

Moments later, Senate Majority Leader Harry Reid, D-Nev., unveiled an alternative that would cut spending by \$2.4 trillion and raise the debt limit by the same amount,

enough to meet Obama's terms that it tide the Treasury over until 2013.

Reid invited Republicans to suggest changes, saying, "This is likely our last chance to save this nation from default."

The Senate GOP leader, Mitch McConnell of Kentucky, accused Democrats of "rounding up 'no' votes to keep this crisis alive," and noted the House had passed two bills to raise the debt limit and the Senate none.

The House, eager to return the Senate's favor rejecting the Boehner bill, set a vote to reject Reid's proposal on Saturday. The Senate set a test vote at about 1 a.m. on Sunday, a middle-of-the-night roll call that underscored the limited time available to lawmakers.

At the same time Reid appealed for bipartisanship, he and other party leaders accused Boehner of caving in to extremists in the GOP ranks — "the last holdouts of the tea party," Sen. Richard Durbin of Illinois called them.

Republicans conceded that the overnight delay had weakened Boehner's hand in the endgame with Obama and Senate Democrats.

But the Ohio Republican drew applause from his rank and file when he said the House, alone, had advanced legislation to cut deficits, and that he had "stuck his neck out" in recent weeks in hopes of concluding a sweeping deficit reduction deal with Obama.

Boehner's measure would provide a quick \$900 billion increase in borrowing authority — essential for the U.S. to keep paying all its bills after next Tuesday — and \$917 billion in spending cuts. After the bill's latest alteration, any future increases in the debt limit would be contingent on Congress approving the constitutional amendment and sending it to the states for ratification.

"With conservatives insisting on the addition of a balanced-budget amendment requirement, Speaker Boehner's bill will now cut, cap and balance" federal spending, said Rep. Jeff Flake of Arizona as Friday's scheduled vote approached.

The White House called the bill a non-starter. Press secretary Jay Carney issued a statement that called it a "political exercise" and said congressional leaders should turn their efforts to a compromise that Obama can sign by Tuesday.

A dollar coin waste at Mint

A billion dollars here, a billion dollars there, and pretty soon, you're talking real money. That sarcastic comment regarding government spending has been attributed to the late U.S. Sen. Everett Dirksen, R-Ill.

Apparently Dirksen was wrong. The government is sitting on \$1.2 billion in \$1 coins that few Americans seem to view as real money.

That was divulged in a recent report to Congress by the Federal Reserve System and the U.S. Mint.

Here's the situation: In 2005 it was decided to honor the presidents with a new series of \$1 coins. Despite the unpopularity of the old Sacagawea \$1 coin for three years, the Mint went ahead with presidential coins the same size.

And size matters to most Americans. The \$1 coins are only slightly larger in diameter than quarters, smaller than fifty-cent pieces. They never really caught on for that reason.

So, the Mint now has a stockpile of 1.2 billion of the coins. No one, ranging from most consumers to most banks, seems to want them.

But the program isn't finished. Only about half the presidents have been covered in the coin series, which is scheduled to continue until all the chief executives have been honored. That could result in a total of \$2 billion in unwanted coins, the Mint estimates.

Some members of Congress already have expressed concern about the boondoggle, asking the Federal Reserve and the Mint for more information about its cost to taxpayers. We hope they aren't too hard on the Mint, which is just following orders.

That's right: The coins are being produced because of a 2005 law enacted by Congress.

Clearly, it ought to be repealed. The \$1.2 billion in stored coins may not be viewed as real money — but it certainly involves real waste.

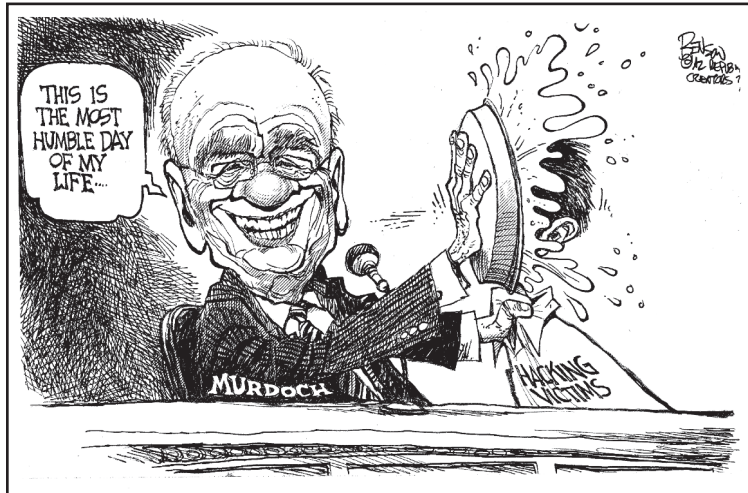

Higher taxes on businesses and households will reverse growth and destroy even more jobs. We hope Obama and lawmakers keep that in mind as they discuss proposals to increase tax revenue.



Uncomfortable women

□ The right to eat. Understood. Hollywood fashion has changed since Jane Russell threw her curves at the camera, but this demand for hollowed-out leading ladies shows contempt for the natural female form.

The last Academy Awards featured actress Anne Hathaway as a host. She showed off her lovely face but had apparently left half her

body at home. Anyhow, Hathaway looked like a corn-fed farm girl next to another presenter, the skeletal Keira Knightley. A former British model, Knightley has told magazines that she's "devastated" by rumors of her being anorexic. Whether she is or isn't, I wouldn't know.

But someone should ask movie directors why they cast semi-starved women in romantic roles. At a certain level of emaciation, the sex hormones actually turn off.

Ideals vs. realities: Weighing risks, gains for Republicans

Many of us never thought that the Republicans would hold tough long enough to get President Obama and the Democrats to agree to a budget deal that does not include raising income tax rates. But they did — and Speaker of the

House John Boehner no doubt desires much of the credit for that.

Despite the widespread notion that raising tax rates automatically means collecting more revenue for the government, history says otherwise. As far back as the 1920s, Secretary of the Treasury Andrew Mellon pointed out that the government received a very similar amount of revenue from high-income earners at low tax rates as it did at tax rates several times as high.

How was that possible? Because high tax rates drive investors into tax shelters, such as tax-exempt bonds. Today, as a result of globalization and electronic transfers of money, "the rich" are even less likely to stand still and be sheared like sheep, when they can easily send their money overseas,

to places where tax rates are lower.

Money sent overseas creates jobs overseas — and American workers cannot transfer themselves overseas to get those jobs as readily as investors can send their money there.

All the overheated political rhetoric about needing to tax "millionaires and billionaires" is not about bringing in more revenue to the government. It is about bringing in more votes for politicians who stir up class warfare with rhetoric.

Now that the Republicans seem to have gotten the Democrats off their higher taxes kick, the question is whether a minority of the House Republicans will refuse to pass the Boehner legislation that could lead to a deal that will spare the country a major economic disruption and spare the Republicans from losing the 2012 elections by being blamed — rightly or wrongly — for the disruptions.

Is the Boehner legislation the best legislation possible? Of course not! You don't get your heart's desire when you control only one house of Congress and face a presidential veto.

The most basic fact of life is that we can make our choices only among the alternatives actually available. It is not idealism to ignore the limits of one's

power. Nor is it selling out one's principles to recognize those limits at a given time and place, and get the best deal possible under those conditions.

That still leaves the option of working toward getting a better deal later, when the odds are more in your favor.

There would not be a United States of America today if George Washington's army had not retreated and retreated, in the face of an overwhelmingly more powerful British military force bent on annihilating Washington's troops.

Later, when the conditions were right for attack, General Washington attacked. But he would have had nothing to attack with if he had wasted his troops in battles that would have wiped them out.

Similar principles apply in politics. As Edmund Burke said, more than two centuries ago: "Preserving my principles unshaken, I reserve my activity for rational endeavors."

What does "rational" mean? At its most basic, it means an ability to make a ratio, as with "rational numbers" in mathematics. More broadly, it means an ability to weigh one thing against another.

There are a lot of things to weigh against each other, not only as regards

the economy, but also what the consequences to this nation would be to have Barack Obama get re-elected and go further down the dangerous path he has put us on, at home and abroad. Is it worth that risk to make a futile symbolic vote in Congress?

One of the good things about the Tea Party movement is that it resisted the temptation to actually form a third political party, which has been an exercise in futility, time and time again, under the American electoral system.

But, if the Tea Party movement within the Republican Party becomes just a rule-or-ruin minority, then they might just as well have formed a separate third party and gone on to oblivion.

Writers can advocate things that have no chance at the moment, for their very writing about those things persuasively can make them possible at some future date. But to adopt the same approach as an elected member of Congress risks losing both the present and the future.

Defense: Cleveland man offered guilty plea in 11 deaths to avoid execution

CLEVELAND (AP) — Attorneys for a man convicted of killing 11 women says jurors who must decide whether to recommend execution should be informed about an offer he made to plead guilty to avoid the death penalty.
However, the prosecution said Friday it would oppose letting jurors hear about the offer to plead guilty when Anthony Sowell’s sentencing phase convenes Monday with the same jury that convicted him July 22.
The motion filed by the defense Thursday said it should be to Sowell’s benefit at the sentencing phase that he “was willing to plead guilty and waive all appeals but the offer was rejected by the state.”
According to defense attorneys John Parker and Rufus Sims, “One or more jurors may fairly wonder why this case went to trial when 11 bodies were found in the defendant’s home and backyard.”

At the time of the offer, Cuyahoga County Prosecutor Bill Mason stopped short of confirming it but said that Sowell’s case was the most appropriate for the death penalty that he had seen in 12 years as prosecutor.
In their response filed with the court Friday, trial prosecutors said the only reason the defense wants to highlight the plea offer is to prevent jurors “from speculating about why a case with overwhelming evidence went to trial.”
The judge’s instructions to jurors that the defendant had the right to a trial is sufficient to prevent such speculation, the prosecution said.
Mason’s spokesman, Ryan Miday, and Sims declined to comment Friday. Both sides are under a gag order limiting comments outside court.
Cuyahoga County Common Pleas Judge Dick Ambrose ruled earlier in the week that the jury may recommend death or life without chance of parole, but ruled out any sentence recommendation that includes a chance for parole.
The sentencing phase could last more than a week.
Sowell, 51, who served 15 years in prison for a 1989 attempted rape, was convicted of killing the women and dumping their remains, including a skull, in his home or burying them in his backyard. He also was convicted of sexually assaulting three women who survived and testified against him.
The women began disappearing in 2007, and prosecutors say Sowell lured them to his home with the promise of alcohol or drugs. Police discovered the bodies in late 2009 after officers went to investigate a woman’s report that she had been raped there.
Most of the victims were nude from the waist down, strangled with household objects and had traces of cocaine or depressants in their systems.

Feds to step up hunt for Asian carp near Lake Michigan

CHICAGO (AP) — Federal officials announced Friday that they will begin intensive monitoring of waterways near Lake Michigan next week after genetic material from the invasive Asian carp showed up in a third consecutive round of testing. Crews will use electric jolts to stun fish, sweep the waterway with half-mile-long nets and conduct additional sampling in Lake Calumet and the Calumet River near Chicago during a four-day period beginning Monday, the Asian Carp Regional Coordinating Council announced Friday.
DNA from silver carp, one of two Asian species threatening to enter the Great Lakes after migrating northward from the South for decades, was found in 11 samples in the lake and the river during testing in July. The U.S. Army Corps of Engineers announced on July 22 that it had found two consecutive samples containing DNA from silver carp and would increase its response if DNA was found in a third sample.
Some scientists say if the large, voracious carp establish a foothold in the Great Lakes, they could unravel the food web by gobbling plankton needed by smaller fish that feed prized sport varieties such as walleye and trout.

Trial delayed so lawyer can get Ohio papers

LISBON — A Lorain man was given additional time before his trial in Columbiana County Common Pleas Court so his new attorney from Pennsylvania can obtain proper Ohio credentials.
Perry Wells, 33, was scheduled for a court trial on two counts of possession of drugs next week, a case for which he was to be represented by court-appointed defense attorney Fred Naragon. However, when Wells appeared in custody Friday at his final status conference for that trial, he brought into the courtroom an additional attorney J.W. Hernandez-Cuebas from Cranberry Township, Pa.
Hernandez-Cuebas said he was only there to represent Wells for another case, which was scheduled to go to trial on Aug. 23. That jury trial is for charges of possession of drugs, weapons under a disability and carrying a concealed weapon. When questioned by Judge C. Ashley Pike, Hernandez-Cuebas said Wells was paying him for one case.

Pike questioned the justification of Wells qualifying for a court-appointed attorney, usually reserved for those who cannot afford an attorney, and using that attorney for one case and not the other.
Wells agreed to allow Hernandez-Cuebas represent him in both cases, “if it makes the court more comfortable,” Wells said. The Pennsylvania attorney told Judge Pike he has applied for the proper credentials to represent Wells in Ohio, but has not yet received the additional paperwork now required as of January.

According to a website for the Fayette County Court of Common Pleas, Hernandez-Cuebas represented Wells when he faced charges there including possession of drugs and animal fighting. Wells is currently serving a prison sentence in Pennsylvania related to those charges, but will remain in Columbiana County Jail until his next hearing.
Pike ruled that next week’s jury trial will be canceled and the jury trial on Aug. 23 will be changed to a status conference to determine if Her-

nandez-Cuebas is ready to proceed on both cases. He said he has already begun talking with the prosecutor’s office about a possible plea agreement.
In one indictment here, Wells is accused of possession of drugs, a first-degree felony, having weapons under disability, a third-degree felony and carrying a concealed weapon, a fourth-degree felony. Documents alleged Wells was caught outside an the Vista Motel in East Liverpool in possession of crack cocaine and with a loaded .38 special revolver, which he is prohibited from possessing due to a previous conviction for cocaine possession. The drug charge alone carries a possible maximum 10-year prison term.
In the second indictment here, court documents alleged he possessed crack cocaine equal to at least 10 grams, but less than 25 grams, on Aug. 28, 2008. He faces a possible prison term of two to eight years on one count of possession, with an additional six to 18 months for the other count.

programs so they remain strong and viable for future generations. Congressman Johnson is a co-sponsor of legislation to stop Congress from raiding the Social Security Trust Fund to pay for pet projects. Congressman Johnson will continue to fight to preserve Social Security and Medicare benefits for those currently receiving them.
Lisbon resident John DeFazio also participated in the protest, dubbed

“Stand up for those that stood up for us.”
“We’re hoping to bring to bear on Rep. Johnson...that enough is enough,” he explained. “We want to preserve intact our social security, Medicaid and Medicare. We believe that there should not be any cuts in those areas.”
DeFazio said instead there should be increased taxes on those in the top 2 percent of income to help bring in

revenue.
“Target the ones who can most afford it,” he said.
Caldwell said he was not bothered by the event’s turnout because the message was all that mattered.
“This plan hurts working people in this area,” he said. “Whether there are 1,000 people here today or three, that message doesn’t change.”

Ohio House leader says voter photo ID bill is dead

COLUMBUS (AP) — The Republican leader of the Ohio House said a proposal to require voters to show photo identification at the polls is apparently dead.
House Speaker William Batchelder supports the proposal but told The Columbus Dispatch he doesn’t expect House lawmakers to see it again. The bill faced opposition from the GOP-controlled Senate and Secretary of State Jon Husted, who is also a Republican.
Husted had said that if the proposal were to pass, it could delay election results for days. Voters without ID would be given a provisional ballot, which would be set aside for up to 10 days until the voter presents picture identification to the local elections board.
The measure passed out of the Republican-controlled House in March along party lines. Proponents argued that it was necessary to prevent people from voting more than once.
However, Democratic opponents said the bill would only serve to disenfranchise those who don’t have photo ID, who are dis-

proportionately elderly and minorities.
Ohio Democratic Party Chairman Chris Redfern said it was clear the proposal would not pass. He called the measure a “dramatic overreach” by Republicans in the House.
Ohio isn’t the only state to toy with the idea of requiring voters to present photo identification. Seven states already have such provisions in their laws, according to the Ohio State University Moritz College of Law, which gathers data nationally on election law.
The Pennsylvania House passed out a similar bill, which awaits consideration in that state’s Senate when lawmakers come back from their summer recess in September.

Investors withdraw as deadline nears
NEW YORK (AP) — Growing nervous as a possible government default draws ever closer, more and more ordinary investors are calling their brokers and moving their money out of stocks and mutual funds for fear of a plunge in the market next week.

The stock market declined for a sixth straight day Friday as financial advisers fielded a new round of calls and emails from clients wondering whether to get out or sit tight.

Investors pulled about \$32 billion out of money-market mutual funds for the week that ended Wednesday, according to fund tracker Lipper Inc. That is just a tiny fraction of the \$2.6 trillion invested in such funds. But the exodus appeared to be accelerating at week's end as Tuesday's deadline for reaching an agreement on Capitol Hill drew near.

Medical device review system 'flawed'
WASHINGTON (AP) — Federal health regulators asked the country's leading medical experts two years ago to recommend ways to improve the government's system for approving most medical devices, ranging from pacemakers to X-ray scanners. On Friday the experts came back with a surprise answer: scrap it because it fails to protect patients. Even more surprising, FDA summarily dismissed the idea.

The Institute of Medicine's panel said in a report that the U.S. government should abandon the 35-year-old system used to clear medical devices because it provides little assurance that the implants are actually safe.

The 12-member group of experts, commissioned by the Food and Drug Administration, is not binding. And experts questioned its real-world impact after the FDA immediately distanced itself from the advice it had requested.

The FDA has been working for more than a year to improve the so-called 510(k) process, efforts that would go to waste if the system is abandoned.

Merck plans more job cuts;
WHITEHOUSE STATION, N.J. (AP) — Retaining files, please wait ... DoneMerck & Co. plans to cut as many as 13,000 more jobs under a new round of restructuring as the drugmaker prepares for generic competition for its top-selling drug and slower revenue growth in the U.S. and Europe.

The announcement came Friday as Merck reported a higher second-quarter profit than a year ago. Merck's stock fell more than 2 percent.

The new cuts would bring to 30,000 the positions eliminated since Merck's November 2009 megadeal to buy Schering-Plough Corp., on top of about 5,000 positions the companies cut before the deal closed.

Most of the new job cuts will come from head-

quarters and other administrative functions. The company also will close some offices and manufacturing sites, CEO Kenneth Frazier told analysts during a conference call. The cuts are to be made by 2015 and won't start in earnest until next year.

Such cuts are part of ongoing streamlining by Merck and many competitors, whose payrolls and costs ballooned in the 1990s as they added thousands of salespeople to promote a surge of blockbuster drugs taken by millions. With those drugs getting generic competition, too few new drugs coming on the market and payers pressing for relief from high prices, the companies are slashing costs in developed countries.

High oil, gas prices lift Chevron 2Q
NEW YORK (AP) — Chevron Corp. said Friday that profit jumped 43 percent in the second quarter as higher oil and gasoline prices made up for a decline in oil production.

The report continued the trend of soaring profits among the major oil companies.

The San Ramon, Calif. oil company reported earnings of \$7.7 billion, or \$3.85 per share, for the three months ended June 30. That compares with \$5.4 billion, or \$2.70 per share, in the year-ago period. Revenue increased 31 percent to \$66.7 billion.

Analysts had expected earnings of \$3.51 per share, according to FactSet.

Chevron's quarterly profit was the largest since it set a company record of \$7.9 billion in the third quarter of 2008. It followed similar big gains for other oil giants. Exxon Mobil Corp.'s earnings rose 41 percent to \$10.7 billion while Royal Dutch Shell's profit nearly doubled to \$8.7 billion. BP made more than \$5 billion in the period following a loss of \$17.2 billion last year.

Mileage standards aim for less fuel

WASHINGTON (AP) — President Barack Obama and automakers ushered in the largest cut in fuel consumption since the 1970s on Friday with a deal that will save drivers money at the pump and dramatically cut heat-trapping gases coming from tailpipes.

The agreement pledges to double overall fuel economy to 54.5 mpg by 2025, bringing even greater under-the-hood changes to the nation's autos starting in model year 2017 and introduce more electric and hybrid technology to pickup trucks. Cars and trucks on the road today average 27 mpg.

When achieved, the 54.5 mpg target will reduce U.S. oil consumption from vehicles by 40 percent and halve the amount of greenhouse gas pollution coming out of tailpipes. It builds on a 2009 deal between the Obama administration and automakers, which committed cars and trucks to averaging 35.5 mpg by model year 2016.

Recession risks up amid slow growth, debt standoff

WASHINGTON (AP) — The economy is at risk of slipping into another recession.

It nearly stalled in the first six months of the year, the government reported Friday. Economic growth was feeble in the second quarter and practically non-existent in the first.

The new picture of an economy far weaker than most analysts had expected suddenly made a second recession a more serious threat — and the threat will rise if Congress can't reach a deal to raise the government's debt limit.

"The only question now is, how much weaker could things get?" says Nariman Behravesh, chief economist at IHS Global Insight.

In April, May and June, the economy grew at a 1.3 percent annual rate, below expectations. And the government changed its growth figure for January, February and March to 0.4 percent, far below the previous estimate of 1.9 percent.

Combined, the first half of the year amounts to the worst six-month performance since the Great Recession officially ended in June 2009.

Over the past year, the gross domestic product — the total output of goods and services in the United States, and the broadest measure of the economy's health — recorded actual growth of 1.6 percent.

Since 1950, year-to-year growth has dipped below 2 percent 12 times. Ten of those times, the economy was already in recession or soon fell into one, says Mark Vitner, senior economist at Wells Fargo Securities.

Normal economic growth is closer to 3 percent.

High gasoline prices leave people with less money to spend on other goods and services. And not all spending on gas contributes to the U.S. economy because some of the money goes to oil-producing countries. GDP figures are also inflation-adjusted, so spending \$1 more for a gallon doesn't mean \$1 of additional help to the economy.

Manufacturing disruptions from the Japan earthquake, cuts in state and local government and tighter household budgets have weighed down the economy, too.

Add to those problems the uncertainty fanned by the political stalemate in Washington, with Republicans refusing to raise the federal government's \$14.3 trillion borrowing limit unless Democrats agree to deep federal spending cuts on the GOP's terms.

Without an agreement, the Treasury Department says, the government won't have enough money to meet all its bills after Tuesday. It will have to cut spending by about 40 percent and choose which programs and beneficiaries receive money and which don't.

The dismal second-quarter report led economists to reduce their estimates for the second half of the year. Capital Economics, which had expected the economy to grow 2.5 percent this year, now says 2 percent looks more likely.

Joel Naroff of Naroff Economic Advisors says he's waiting until the debt-limit deadline passes to revise his economic forecasts for the rest of 2011. He knows he'll scale back his estimates. He just doesn't know how much.

If a deal isn't reached for another month, Naroff estimates there's an 80 to 90 percent chance that the spending cuts would tip the economy into recession. Even if there is a deal, it would likely trigger significant spending cuts that would slow growth, at least in the short run.

"You kick the federal government, and the economy is going to be doubled over in pain," Naroff says.

How to prevent deconditioning

DEAR DR. DONOHUE: I injured my knee about a week ago and am in a cast-like contraption that makes it hard to exercise. I plan to play my senior and third year of varsity football in the fall. I'm going to be way behind my buddies who are exercising every day. What can I do to stay in shape? — M.R.

ANSWER: Immobilization leads to regression of physical fitness. But you're not completely immobile.

First, I'll give you the bad news. If you are among the elite fit, three months without exercise decreases your aerobic fitness by 50 percent. Aerobics is the kind of fitness that permits endurance. Long-distance running, long-distance swimming and any sport where the exerciser moves more or less constantly are considered aerobic exercise.

Strength is a different issue, but the facts are similar to those for aerobics. If you had performed strength training by lifting weights for six months and then stopped for three months, your strength would decrease by half of what it was at its peak.

I don't think either of these applies to you. You plan to be out of your contraption by the start of school. That's not three months. Furthermore, you can still be active. You can maintain aerobic conditioning by nonstop exercising of your arms. You use light weights and do exercises that increase your heart rate and breathing rate but don't exhaust you. You can do arm-strengthening exercises, too. Those exercises transfer some benefits of strength training to the legs, believe it or not. That's been demonstrated in people who had bad arthritis of the hips and knees, so strength training of their legs was not an option for them. Strength comes back relatively quickly once you can start leg strength training. Muscles have memory. That memory permits restoration of muscle strength more quickly than it would be restored had you never exercised.

Childhood assaults still haunt 17-year-old

DEAR ABBY: I'm a 17-year-old female senior in high school. I was coerced into sex when I was 12 by a 19-year-old neighbor. He raped, molested and beat me repeatedly for two months. I come from a religious family. I was very sheltered and didn't understand most of what was happening at the time. It wasn't until I had Sex Ed that year that I fully understood.

Mom had always told me not to let anyone touch me because it was dirty and wrong. I felt guilty because I knew "something" was wrong. When I told my neighbor about the guilt, he taught me how to cut myself using a razor blade. I never told my family (or anyone else, for that matter) about what had happened to me, and I continued cutting until last year when my mom found out. I have been in and out of counseling since then.

I have horrible nightmares nearly every night. I relive memories of him beating me, molesting me and raping me. The nightmares are getting worse, and I'm falling asleep during the daytime. I don't know how to make them stop. Abby, can you help me? — NIGHTMARES IN WICHITA, KAN.

DEAR NIGHTMARES: None of what happened was your fault. You were a child and that neighbor was an adult who took advantage of your youth and inexperience. The feelings you're experiencing are not unusual for rape victims — fear, anger, shame, guilt, loss of power and isolation.

If you will make a police report, it will help you to regain a sense of control. It may also prevent other children from being victimized by this monster. If possible, ask to talk with a female police officer — although many police departments provide special training to all their officers so victims are treated in a sensitive and caring manner.

Being able to give voice to your feelings will go a long way toward making your nightmares go away. It will help you immensely if you'll talk with a professional counselor at a rape treatment center or crisis center. For you, that would be the Wichita Area Sexual Assault Center. Its 24-hour toll-free number (for Kansas residents only) is (877) 927-2248. The website is www.wichitasac.com. Please don't wait. People there will help you if you'll give them a chance.

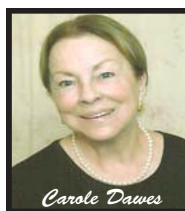

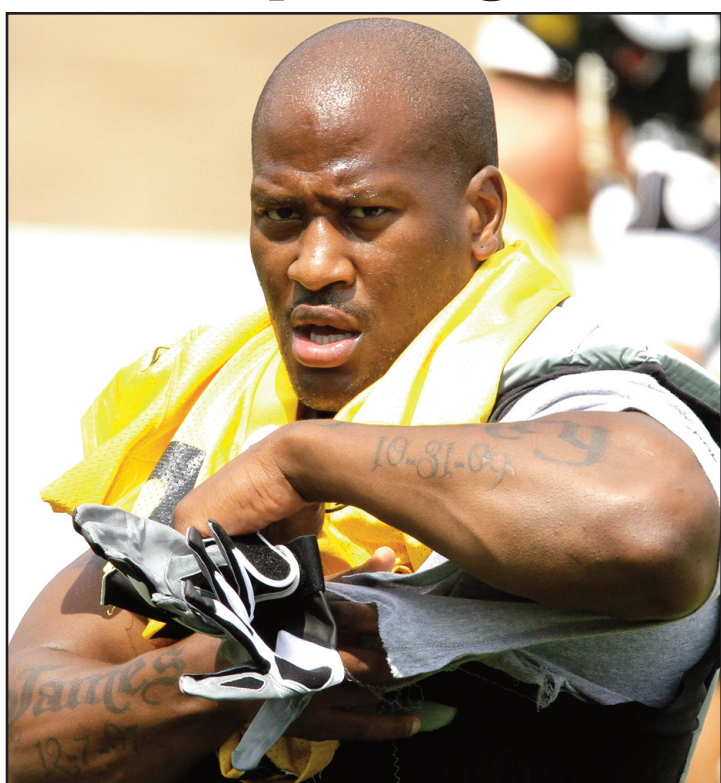

'I was speaking out of anger'

LATROBE, Pa. — James Harrison is an emotional guy. Always has been. The Pittsburgh Steelers linebacker plays with an intensity few in the NFL can match.

Yet the four-time Pro Bowler knows that fury has its limits, and Friday he admitted he blew right past them in a magazine article earlier this month in which he used an anti-gay slur when talking about commissioner Roger Goodell and criticized teammates for their play in Pittsburgh's Super Bowl loss to Green Bay.

"The comments I made about Roger Goodell were inappropriate at the least and way out of line," Harrison said.

"I was speaking out of anger and frustration at the time and any comments that I may have made that offended anyone with my careless use of words, I apologize."

Harrison used the slur while expressing his aggravation with the league's new player safety rules. One of the NFL's fiercest hitters, the volatile 33-year-old drew \$100,000 in fines for illegal hits last season. He thought he was venting about the new rules — and not Goodell personally — while calling him a "crook" and a "devil."

It didn't read like that, and Harrison now knows he should have used a "better vocabulary" when talking about the

KILLARNEY, Ireland — Darren Clarke failed to make the cut at the Irish Open on Friday, two weeks after he won the British Open for his first major title.

Germany's Marcel Siem eagled the 16th hole and took the second-round lead at 10-under 132. India's Jeev Milkha Singh, who had a 70 after opening with a 63, and Denmark's Soeren Hansen (66) were one shot back. Spain's Ignacio Gar-

rido was two strokes behind.

U.S. Open champion Rory McIlroy and 2010 U.S. Open winner Graeme McDowell looked in danger of following Clarke out of the tournament in what would have been a big blow for Northern Ireland.

But McIlroy made three straight birdies from Nos. 14 to 16 to finish at 68. McDowell birdied his first two holes in a 66. Both were at 4-under 138, with Clarke at 143.

"If I get off to a good start tomorrow and post a number, then I feel I can give myself a good chance," McIlroy said.

McIlroy has been feuding with Jay Townsend, a U.S. golf commentator and former European pro. On Thursday, Townsend criticized the 22-year-old star and his caddie, J.P. Fitzgerald. After Townsend called McIlroy's opening-day tactics "silly" and Fitzgerald's management "shocking," McIlroy sent him a message on Twitter. He called Townsend a "failed golfer" who should "shut up."

McIlroy said Friday he spoke with his parents and manager about staying calm,

Billy Butler went deep twice and Alex Gordon also connected for Kansas City, which has won seven of 10. Butler hit a two-run shot in the first and a solo drive in the eighth, giving him five long balls in a four-game homer streak.

Butler came to the plate right after Cabrera's grand slam in the fourth, and Cleve-

land starter Carlos Carrasco promptly threw one at his head on the first pitch. Players from both dugouts and bullpens came on the field, and Carrasco was ejected.

Francis (4-11) won for the first time since June 10. He allowed four hits, struck out six and walked one.

The Indians, who were no-hit by Angels right-hander Ervin Santana on Thursday, have lost seven of eight, managing just 13 runs during the slide. Right fielder Kosuke Fukudome, acquired from the Chicago Cubs on Thursday, went 0 for 4 in his Indians debut.

Simpson, de Jonge share lead at Greenbrier Classic

WHITE SULPHUR SPRINGS, W.Va. (AP) — Brendon de Jonge rode a wave of Hokie fever to a share of the second-round lead at the Greenbrier Classic.

De Jonge shot a 3-under-par 67 Friday and was tied with Webb Simpson at 7 under midway through the tournament.

Among those failing to advance to weekend play were Phil Mickelson, whose streak of making 17 straight cuts ended, and defending champion Stuart Appleby. Both finished 3 over, missing the cut by two strokes.

With shouts of encouragement all around him, de Jonge, a former Virginia Tech golfer, is flourishing for the second straight year at The Greenbrier resort, less than two hours from his college stomping grounds.

"It's a little bit of adrenaline," de Jonge said. "Keeps you going. It's always a little pick-me-up if you're struggling a little bit. It's fun. It's nice to hear 'Go Hokies' on every tee."

De Jonge has played the Old White TPC course many times and he finished third in last year's inaugural tournament at 17 under. It was one of three third-place finishes in 2010 that helped him earn a career-best \$2.2 million.

The native of Zimbabwe is

the tour leader in birdies, yet admits he needs to work on eliminating the bogeys. His only one Friday was a three-putt on No. 11.

"I think the biggest thing is just getting out of my own way," de Jonge said. "It's very, very difficult to win out here. It's difficult to win anywhere. Staying in your own routine, I guess, is the best way to put it."

Simpson couldn't get any

momentum going until he made three birdies on the back nine and shot 68.

The former Wake Forest golfer is playing less than five hours from his old campus. He grew up in North Carolina and moved to Charlotte earlier this year.

His own cheering section will get a bit bigger on Saturday.

"I told my wife today I'm

going to go out and be in the lead, so you've got to come for the weekend," Simpson said.

Both Simpson and de Jonge are chasing their first career victories. The tournament champion will earn a spot in next week's Bridgestone Invitational.

Like last year, when Appleby came from a seven-stroke deficit and shot 59 in the final round to win, it's any-

one's tournament. Thirty-five players were within five shots of the lead entering the third round.

Simpson and de Jonge were the only two of the top 10 from the first round to break par in the second. The cut was three shots higher than last year.

First-round leader Trevor Immelman made just two birdies, shot 70 and was at 6 under.

Looking for his first win since the 2008 Masters and less than two years removed from wrist surgery, Immelman isn't thinking about how far he has come if he can advance to Bridgestone.

"It would be fantastic," he said. "And I'd love to be there. But (it's) the furthest thing from my mind."

Tied at 5 under were Scott Stallings (65), Michael Letzig (66), Gary Woodland (70), Brian Davis (64) and Derek Lamely (70). Lamely was tied for the lead before a stretch of three bogeys and a double-bogey over seven holes.

Canadian Chris Baryla made five birdies in an eight-hole stretch in his morning round to rocket to the top of the leaderboard at 8 under, then made triple-bogey on the par-4 sixth. He shot 69 and was in a group of six at 4 under.

Australian Steven Bowditch moved to 6 under after an early birdie, but had a double-bogey and three bogeys on his final four holes to fall to even par.

Heavy rains makes a USGA setup too slow, Browne stays on top

TOLED (AP) — At most events set up by the U.S. Golf Association, there's a long line of players complaining about how hard and slick the greens are.

Thanks to heavy rains overnight — and almost 4 inches of precipitation in the last week — that isn't a problem at the U.S. Senior Open at Inverness Club.

In Friday's second round, delayed 2 hours and 45 minutes by an early morning cloud-burst, the problem was the greens — usually as fast as a slippery slide — were downright slow and spongy.

Olin Browne followed a record-tying 64 with a solid 69 to take a one-shot lead over a talent-laden leaderboard.

Browne, who led by two strokes after matching the tournament's low first-round score, had a double-bogey and a bogey but added five birdies — including 3s on the two closing par 4s. He is at 9-under 133.

Mark O'Meara (68) was one shot back, with Mark Calcavecchia (67), Joey Sindelar (66) and Michael Allen (69) at 135. Peter Senior (67) was

three back, with Corey Pavin (69), Trevor Dodds (69) and Kiyoshi Murota (69) at 137.

A lengthy rain delay in the morning prevented the field from finishing the round.

"I think all of us are a little thrown off," said Jay Haas, who shot a 69 after the storms left. "We get a downhill putt and I don't think people are getting the ball to the hole because we just think it's going to be fast."

Usually, a USGA setup involves narrow fairways, greens that register "marble floor" on the Stimpmeter and high rough.

Some of the players are thankful that Inverness isn't baring her usual fangs.

"I played here when (Paul) Azinger won," Senior, referring to Azinger's playoff win over Greg Norman in the 1993 PGA Championship. "You'd get on the wrong side of the hole and you had 6 or 7 feet to clean up. So we're pretty fortunate that the greens are as soft as they are. Even when you miss it short side now, you can still get up and down reasonably easy."

The weather forecast is for clear skies, temperatures in the

90s and high humidity for the rest of the weekend.

QUOTE OF THE DAY: Nick Price, on going from the cool and windy climate at last week's Senior British Open to the heat and humidity at this week's U.S. Senior Open: "It feels like we've gone from Alaska to the Amazon."

NOT HIS FAVORITE: It was a loaded question, but Calcavecchia didn't care: Were you a good U.S. Open player?

"No. I was a horrible Open player. I've never sniffed it in a U.S. Open," said the loquacious former British Open champion.

He said it's easy to see why.

"Historically, the rough's usually chip-out rough and I'm not exactly (ultra-straight) Calvin Peete or David Toms or Fred Funk with the driver. I tend to hit it a little bit crooked, and that usually doesn't pan out well in the U.S. Open."

There are exceptions, he said.

"Phil (Mickelson) has no idea where it's going (off the tee) and he's had five seconds in the U.S. Open," Calcavecchia said, drawing laughs from

reporters. "So I guess that disproves my theory. But I'm not Phil, either."

HOMETOWN BOY: Steve Schaff almost waited too long to sneak back into his hometown. Now he's making the most of it.

Schaff was 3 over par with four holes left in his U.S. Senior Open qualifier in Florida, but finished birdie-ace-birdie-birdie to make it into a playoff with Damon Green, whose day job is caddieing for Zach Johnson.

Even though Schaff, who attended the University of Toledo, lost out in a playoff, he still joined the field this week as an alternate.

He showed consistency — 39-39-78 each day — but was doomed to miss the cut at Inverness Club.

Still, he was thrilled to even be a part of the tournament.

"Day 2 of the dream," he said with a smile after Friday's second round. "It was really great. I felt a lot better today. Just being out there with John Cook and Peter Jacobsen was a lot of fun. I really wish I could have played better. I didn't

score great, but this was an experience of a lifetime, for sure."

SELF-IMPROVEMENT: Mark Wiebe's hopes in the U.S. Senior Open were slipping away. Then, like any good do-it-yourselfer, he restructured his game.

After making two bogeys and a double-bogey in a four-hole span in his opening nine holes in Friday's second round, Wiebe turned things around by playing the last 10 holes in 3 under to shoot a 67 that left him a 3-under 138 through 36 holes.

So, was the problem more mental or physical, Mark?

"No, it's mental. I made a couple of bonehead moves and I learned from them and stopped making them," he said.

LATE LAPSE: Japan's Kiyoshi Murota had the lead all to himself in the U.S. Senior Open.

Then came two troublesome holes.

Murota made bogey and double-bogey at Nos. 8 and 9 to finish up his second round Friday with a 69 that left him at 5-under 137.

tackle alongside Ahtyba Rubin.

Re-signing Mitchell, who never got to play last year when Eric Mangini was head coach, is a huge plus for the Browns. Mitchell had five sacks in three seasons and two games in 2010 with the Vikings.

caught them off guard. According to reports, the Browns offered more money and a longer deal, but Wright chose to sign with the Lions for one year.

Wright is hopeful he can return to his 2009 form after a miserable 2010 season so he can cash in on free agency next year.

Losing Wright isn't devastating to the Browns, but it does mean they have to find a cornerback among the free

agents still looking for work. As it is, Sheldon Brown and Joe Haden would be the starting cornerbacks but defensive coordinator Dick Jauron needs a third to play in nickel situations. The Browns drafted Skine in the fifth round, but he is considered a special teams player.

Wright was second-round draft choice in 2007. He played well his first three seasons while starting 47 of 48 games.

His problems began last year when he gave up three touchdown passes to Anquan Boldin in a game against the Ravens in September. He eventually lost his starting job to Haden and ended up on injured reserve.

issue and the commissioner.

The 2008 AP Defensive Player of the Year hasn't spoken to Goodell since the article was published and isn't sure whether he'll be disciplined by the league.

"I don't think (Goodell) is a guy that's going to hold something on a personal level (against me professionally)," Harrison said. "I attacked him on a personal level, which wasn't right. I don't expect anything to be done."

There's also the question on whether Goodell would even have the power to suspend or fine Harrison.

The comments were made during the NFL lockout, meaning technically Harrison wasn't working for the league at the time. Harrison said he wouldn't decide whether to fight any penalty until it is levied.

The team has not indicated

it will discipline Harrison, though coach Mike Tomlin agreed with Harrison's assessment that his words were inappropriate. Harrison spoke to owner Art Rooney recently but hasn't been excluded from any team activities as the defending AFC champions opened training camp.

One place where the article didn't create a stir appears to be the locker room. Harrison reached out to running back Rashard Mendenhall — whom Harrison called a "fumble machine" — and quarterback Ben Roethlisberger — whom Harrison said needed to "stop trying to act like Peyton Manning" — after the issue hit newsstands.

Both players said there were no hard feelings and are well aware that Harrison's temper can sometimes get the best of him.

"He called me that morning (the article came out) and left me a voice mail because he was sure I wanted to talk to him and I had no idea what he

was talking about," Roethlisberger said. "So I called him and he explained everything and it literally was nothing, absolutely no linger effects whatsoever."

Roethlisberger threw a pair of interceptions in Pittsburgh's 31-25 loss to the Packers, with both picks leading to touchdowns. The way the quarterback looked at Harrison's outburst, all he was doing was stating the obvious.

"No one is going to be harder on me than I am and I told James, I told everybody that it was my fault we lost the Super Bowl anyway, so if he wants to reiterate what I said, that's fine," Roethlisberger said.

The players appear eager to put the incident behind them and move forward, though Harrison is hardly the only Steeler to make waves off the field during a bumpy offseason for one of the league's marquee franchises.

Wide receiver Hines Ward won "Dancing With the Stars"

then was arrested for DUI in Georgia, a charge that drew national headlines and took some of the shine off Ward's image as a humble and hard-working team leader. He declined to talk specifics about his arrest, but understands why it was a big deal.

"That's what comes with it, the price of fame," Ward said. "Every little thing you do is in the media eye and the public's eye. For me it's a learning process. You can't be one of the boys and do things, you have to look at the big picture. I'm confident in the end that everything will work out."

Colon and Scott, along with the cornerback Ike Taylor and kicker Shaun Suisham, can't practice until next week, though the Steelers received a boost on Friday when first-round pick Cameron Heyward signed and participated in a rain-shortened practice.

The team's third-round pick, cornerback Curtis Brown, signed late Friday, meaning all seven draft picks will be in camp this weekend.

The rookies will try and help lead the Steelers back to the Super Bowl. The loss to the Packers has hung with Roethlisberger for months. Even his wedding last week to Ashley Harlan, a physician assistant, hasn't made him forget about his disappointment in Dallas.

"We can't dwell on the past," he said. "We have to focus on the future and what's to come."

Mentor of Terrelle Pryor cleared

COLUMBUS (AP) — The mentor for former Ohio State quarterback Terrelle Pryor was investigated and cleared by the NCAA in 2008 of allegations that he improperly acted as a booster while helping the player pick a college, according to records released Friday.

Less than three years later, mentor Ted Sarniak was a central figure in coach Jim Tressel's downfall and Pryor's departure from Ohio State.

The records show the NCAA in 2008 ruled in favor of Sarniak, a businessman and hometown friend in Jeannette, Pa., who went with Pryor on several recruiting visits.

"Our staff could not conclude that the benefits provided by (Sarniak) to the prospective student-athlete constituted a violation," the NCAA's Amy Huchthausen wrote in a letter dated Sept. 17, 2008, to Ohio State athletic director Gene Smith.

However, Sarniak was told to he could no longer provide money, meals, tickets, presents or a cell phone to Pryor.

"Mr. Sarniak may continue his relationship with Pryor and his family," Ohio State NCAA compliance director Doug Archie wrote to Sarniak on Sept. 5, 2008. "However, since the relationship does not meet the NCAA's definition of a 'pre-existing relationship,' NCAA rules require that the relationship must change."

Sarniak on Friday declined to comment. It has not been alleged that Sarniak was involved in any wrongdoing related to the scandal that forced Tressel out.

The 2008 investigation found that Sarniak was mistakenly provided free lodging at a university hotel during Pryor's official visit in November 2007, but the mistake was discovered and Sarniak was later billed.

The investigation also alleged Sarniak improperly paid for the meals of two assistant coaches visiting Pryor in Pennsylvania in December 2007.

All "...expenses incurred on this recruiting trip by the coaches, including the cost of meals, should have been paid for by the institution," Huchthausen's letter said.

It was unclear Friday what the outcome of this allegation was, although it appears to have been reported in a summary of secondary violations

Ohio State provided to the NCAA earlier this month.

Secondary violations are common breaches of NCAA rules, usually unintended and requiring education of a coach or a player or minor sanctions against a university.

In April of 2010, Tressel received an email from a tipster informing him that Pryor and other players had accepted improper benefits from a local tattoo-parlor owner. Tressel did not notify his superiors or the compliance department at Ohio State, as required by NCAA rules and his contract. But he instead forwarded the email only to Sarniak.

Asked why he thought first of Sarniak, he told NCAA investigators, "I felt from a safety standpoint that I needed to alert Ted to the gravity of that" (since Pryor was one of the players involved).

That decision led to Tressel being forced to resign on May 30. Pryor subsequently left Ohio State a year early and is hopeful of being included in a

possible NFL supplemental draft.

Sarniak has not been accused of any bylaw violations throughout a lengthy NCAA investigation into the Ohio State program covering the past few months.

The records released by Ohio State on Friday had been sought by The Associated Press through a public records request earlier this spring. But Ohio State's Office of Legal Affairs declined to release the records because it said doing so would mean giving up information without the student's consent.

"We believe the records released today comply with the University's requirements under the Ohio Public Records law and our obligations to adhere to all applicable laws with regards to protecting the education records of its students," said university spokesman Jim Lynch.

Sarniak, who runs a glass factory, has declined to speak publicly since the NCAA prob-

lems of Ohio State and Pryor first came to light last December.

Pryor was a three-year starter for the Buckeyes, tying the school record for touchdown passes and becoming Ohio State's leading rusher among quarterbacks. But he was always the center of controversy, putting down opponents, complaining about not being selected All-Big Ten or visibly admonishing teammates after dropped passes or missed assignments.

Last December, after Ohio State had won its record-tying sixth consecutive Big Ten title, it was revealed that Pryor and five teammates had received improper benefits from a Columbus tattoo-parlor owner. Pryor and four others were suspended for the first five games of the 2011 season — but permitted by the NCAA to play in the Buckeyes' 31-26 victory over Arkansas in the Sugar Bowl — with another player suspended for the first game this fall.

In January, Ohio State uncovered emails Tressel had received in April 2010 telling him of his players' NCAA violations. He had apparently told none of his bosses or the compliance department at Ohio State, contrary to his contract and NCAA rules.

After a series of embarrassing revelations dealing with the football program, Ohio State officials met with Tressel and told him he needed to step down. He resigned on May 30.

Ohio State goes before the NCAA's committee on infractions on Aug. 12. The university has offered to vacate the 2010 season, including the bowl victory, and to go on two years of probation. The committee, whose final decision is not expected until later this fall, could tack on bowl bans, fines and recruiting limitations on top of what Ohio State has proposed.

Smith declined to be interviewed on Friday, saying he was "not speaking again until the hearing is done."

Tressel had made numerous phone calls and sent text messages to Sarniak in the wake of the first disclosure of Pryor's involvement with Edward Rife, the tattoo-parlor owner, who is now awaiting sentencing on federal drug-trafficking and money-laundering charges.

Clemens accuses prosecutors of provoking mistrial

WASHINGTON (AP) — With his trial abruptly cut short, former baseball star Roger Clemens argued Friday that prosecutors intentionally goaded him into asking for a mistrial and asked a judge to throw out his indictment on charges of lying to Congress.

Clemens argued that a new trial would violate his constitutional right against the double jeopardy of facing the same charge twice.

His lawyers said prosecutors' revelation that a teammate told his wife that Clemens confessed to using a drug "was no accident." They said the prosecutors chose to ignore U.S. District Judge Reggie Walton's order against using her testimony so they could provoke a mistrial because their case was going badly. The mistrial came on the second day of testimony in a trial that had been expected to last four to six weeks.

Most legal experts who reviewed copies of the Clemens transcripts for The Associated Press say he probably will face a second trial under rules established by the Supreme Court. They said that when a mistrial is requested by the accused, the general rule is that the guarantee against double jeopardy does not prevent another trial unless the judge finds prosecutors provoked a mistrial. But the experts point out there's no indication prosecutors would have wanted to start their case over so soon.

But the Clemens team argued "this is the rare case" that meets the standard.

"By the time the government provoked the mistrial, its highly experienced counsel had suffered a series of setbacks that cast doubt on the case against Mr. Clemens," defense attorneys wrote. They pointed out that prosecutors have not said they made a mistake and argued that the violations "were critical, hotly contested pretrial issues that no experienced prosecutor could simply have missed when it came time to finalize exhibits and prepare witnesses."

Prosecutors have three weeks to respond. Walton has set a Sept. 2 hearing on the retrial issue.

Ochocinco cheered at Pats' camp

FOXBOROUGH, Mass. (AP) — It looks like Chad Ochocinco won't have to change his name again.

That was the colorful wide receiver wearing his usual number 85 at practice for the New England Patriots on Friday, one day after being traded by the Cincinnati Bengals.

Ochocinco, a reference to the Spanish words for the numbers 8 and 5, legally changed his name from Johnson before the 2008 season. On Friday, he had the number worn last year by rookie tight end Aaron Hernandez, who hasn't practiced following hip surgery in February. Hernandez was on the field wearing shorts with the number 81.

Fans cheered when Ochocinco took the field for the afternoon session. Tom Brady connected on passes to him. Teammates went over play charts with him.

"I've watched him for a long time," Brady said. "He brings a lot of energy to the team."

The verbose Ochocinco didn't speak with reporters, although the Patriots officially announced the trade for undisclosed draft considerations on Friday. They still haven't announced the trade for Washington Redskins defensive tackle Albert Haynesworth.

Each transaction was confirmed on Thursday by persons familiar with the deals who spoke to The Associated Press on condition of anonymity because none of the teams had announced the moves yet.

Ugandan Little League team strikes out on visas

STATE COLLEGE, Pa. (AP) — A youth baseball team from Uganda has lost its bid to become the first team from Africa to play in the Little League World Series because of discrepancies over players' ages and birth dates.

League and team officials did everything possible to ensure players on the Rev. John Foundation team from Kampala were qualified and had documentation, said a league representative, Richard Stanley, of New York City, told The Associated Press on Friday. Children who are 11 or 12 as of April 30 can play in the World Series, which is held each August in South Williamsport, Pa.

Stanley is credited by Little League with introducing and establishing the organization in Uganda by building a baseball academy several years ago. He said Friday issues arose when ages and birth dates listed on documentation didn't match those offered by parents, guardians or the players themselves during interview with U.S. consular officials at the U.S. embassy in Kampala.

Several players provided false birth documents to make their ages appear younger, said a State Department official in Washington, speaking on condition of anonymity because visa records are confidential.

Until now, the Ugandan team's success was considered a home run for Little League and baseball's international growth. The team would have been the first squad from Africa to play in the 65-year history of the World Series.

Stanley said birth records in Uganda are not strictly tracked, as in the United States.

Stanley and State Department spokesman Mark Toner both said it was unclear how many visas were denied.

Woods enters the PGA Championship

JOHNS CREEK, Ga. (AP) — Tiger Woods already has missed two major championships this year. He doesn't plan on missing the last one.

Woods has formally entered the PGA Championship, to be played Aug. 11-14 at Atlanta Athletic Club. He has been out of golf for nearly three months so that injuries to his left leg can properly heal. He will make his return next week in the World Golf Championship event at Firestone.

PGA spokesman Julius Mason said Friday that Woods' agent, Mark Steinberg, told him that as long as everything goes well at Firestone and there are no complications to his left leg, that Woods intends to play the PGA.

Woods has failed to win the last nine majors he has played, one short of matching his longest drought.

Tied with Lincicome were European Tour rookie Caroline Hedwall of Sweden and Japan's Mika Miyazato, who matched their opening 69s, and South Korean Amy Yang, who had a 70.

In a group at 5 under was Paula Creamer.

"If I just go out and make as many birdies as I have been and eliminate the bogies then I feel I'll be right there on Sunday," said Creamer, who had a second-round 70.
